PART - I

Special Notice-

Statutory Protection to Insolvency professional after notification of Insolvency and Bankruptcy Code, 2016.

After notification of the Insolvency and Bankruptcy Code, 2016, Insolvency Professional play a key role in managing rescue and liquidation process envisaged under this Code. In the rescue process, the insolvency professional is the resolution professional and gathers financial information about the debtor, verifies the claims of the creditors, constitutes a committee of creditors on the basis of credit exposure, safeguards the estate, runs the business of the debtor and helps in reaching and administering a consensual rescue plan. In a liquidation proceeding, the insolvency professional is liquidator and sells the assets of the insolvent company and uses the proceeds to pay off all its creditors.

Section 233 of the Insolvency and bankruptcy Code, 2016 provides protection to an insolvency Professional from the legal suit or other legal proceedings for anything done or intended to be done in good faith under this Code or rules or regulations made thereunder.

Section 19 of the Code provides that the personnel of the corporate debtor, its promoters or any other persons associated with the management of the corporate debtor shall extend all assistance and co-operation to the interim resolution professional as may be required by him in managing the affairs of the corporate debtor.

The insolvency professionals, being appointed by Adjudicating Authority as interim resolution professional may face hindrances in taking over the, management of the corporate debtor. It is to be borne in mind that after notification of the Code, and in terms of section 236 (2) of the said Code, there is bar on trial of offences against an insolvency professional except on a complaint filed by the Insolvency and Bankruptcy Board of India or the Central Government or any person authorised by the Central Government in this behalf.

Apart from this, Section 238 of this Code shall have effect, notwithstanding anything inconsistent therein contained if any other law for the time being in force or any instruments having effect by virtue of any such law. In view of the statutory mandate of the Code, all SPs/ CPs/ Range DIGPs/ Zonal IGP are requested to sensitize the field functionaries to strictly comply with the above provisions of the Code. While discharging the duty of the insolvency professional, the concerned Police Station shall make proper and effective assistance to the resolution professional in valuation of the company and shall initiate suitable action against the corporate debtor if needed presuming that the corporate debtor is not obeying the order of the Court.

CID Cyber PS case no. 07/21, Dtd. 27.07.21, u/s 417/419/420/120B/34 IPC

On 27.07.2021 the above referred case was started on the basis of the written complaint of one Ajim Hossain Piyada to the effect that on 07.07.21 he received a phone call from phone no 9798821850. The caller convinced him as an officer of Bajaj Finance and cheated him with Rs. 32880/- . Again, on 08.07.21 he again received call from 9674863950, 9062088024 & 9830221345 where the callers introduced themselves as officers of Aditya Birla Finance. The complainant sent some documents to them as per their direction through WhatsApp. They told him that a loan of Rs. 3, 45,000/- has been sanctioned in his name but for that he had to buy an insurance policy of Rs. 5,800/- . They directed him to send Rs. 5,800/- to their Bank A/C No. 920020004930928. The complainant sent the said amount to that account. Later on, he realized that the miscreants cheated him in both the occasions.

PART- IV –

1) Miscellaneous Notices –

Prohibition of using disinfection on human being involving spraying or fumigation or any other modality.

Order dated 05.11.2020 of Honble Supreme Court of India passed in connection with WP (C) No.560 of 2020 and the guideline / advisory laid down by the Ministry of Health & Family welfare, regarding the ban on the use of disinfection on human being.

Order issued by Sri Rajas Bhushan, Secretary (H & FW), public Health Division, Government of India, sent under Memo No. 2-21020/159/2020-PH dated 12.11.2020 alongwith the correspondence of Special Secretary, Government of West Bengal, Home & Hill Affairs Department, internal Security Branch, Secret Section, Howrah sent under Memo No. 358(4)-1 SS/2M-21/20 dated 9th March, 2021.

It is worth mentioning here that Hon'ble Supreme Court of India has passed the following order in connection with the above noted case, which runs as follows operative portion of the order.

- I) The respondent No. 1 may consider and issue necessary direction in exercise of powers vested in it under the Disaster Management Act, 2005, regarding ban/regulation on the usage of disinfection tunnels involving spraying or fumigation of chemical/organic disinfectants for the human being. Or
- II) There shall be similar consideration and directions by the respondents as indicated above with regard to exposure of human being to artificial ultraviolet rays.

On the basis of the above noted order of Hon'ble Supreme Court of India, Ministry of Health & Family Welfare, public Health Division has issued the following direction upon all States/Union Territories:-

Usage of disinfectants on human being involving spraying or fumigation or any other modality shall not be done. The matter of usage of artificial ultraviolet rays is being deliberated and after due deliberations appropriate directions will be issued.
