The accused person confessed that he was carrying bulk consignment from Bhubaneswar Orissa and scheduled to deliver at Jalangi PS area, Murshidabad Dist. through their agents.

**ii) Usthi PS Case No. 238/23 Dt- 24.05.2023 U/S - 363 IPC.**

The fact of the case is that on 24.05.2023, one Krishna Chakraborty W/O- Late Kalikanta Chakraborty of Usthi PS area lodged a written complaint stating that on 14.03.2023 at about 07.00 hrs her minor daughter aged about 17 years was found missing. Officers of CID West Bengal went all out in the said case and using reliable source information and CDR analysis, was able to recover the minor VG.
