- (C) Property found in the possession of arrested persons
  - 1. Sahebganj PS Case No. 56/19 Dated 30.01.19 u/s 21 (C) NDPS Act was started on the complaint of Shri B.R. Tendy, Insp., Coy Commander, Sabri BOP, 43 Bn. BSF, Sukarurkuthi GP, PS Sahebganj, Cooch-Behar against Ekramul Hoque s/o Hussain Ali of Sukarurkuthi, PS Sahebganj, Cooch-Behar alleging that on 29.1.19 at about 22.30 hrs at BP No. 940/6-S, between BFL No. 10 & 11, the duty party of BSF observed movement of the smugglers and chased them. Meanwhile, the above noted person was apprehended by the BSF with 50 bottles of phensedyl, 25 bottles of Eskuf Cough Syrup and one NIKIA Mobile phone recovered from his possession.
  - 2. Mogra PS Case No. 30/19 Dated 29.01.19 u/s 21 (C) NDPS Act. On 29.01.19 O/C Mogra PS received a suo-moto complaint from SI Sujit Kr. Roy of Mogra PS against the accused person namely Prasenjit Biswas @ Babu (26) s/o Pradip Biswas of Tribeni B.P.R Colony, PS Mogra, District Hooghly to the effect that on 28.01.2019 at 20.20 hrs. received a secret source information that on the night one person would be arriving at Tribeni side through Kalyani highway in between 21.00 hrs to 23.00 hrs from Kalyani side and he will be carrying one plastic jar in a polythene bag containing codeine mixture. As such getting information he informed to superior and he along with officer conducted raid near Iswargupta Setu starting at Mogra side and detained the suspect person with one plastic jar in a polythene bag containing codeine mixture. On asked he did not produce any valid documents in respect of such quantity of codeine mixture. Then SI Sujit Kr. Roy seized approx 11.8 kg. of codeine mixture from the possession of said person and arrested the above noted accused person.
  - 3. Kharagpur (L) PS Case No. 64/19 Dated 27.01.19 u/s 20(ii)(C) of NDPS Act, 1985. This case was started on the complaint of SI Sujoy Layek of Kharagpur (L) PS that on 26.01.19 at 21.20 hrs acting on source information he along with force held raid at the house of Sambhu Jana s/o Kinkar Jana of Sanporapara, PS KGP (L) in presence of Shree Nabyendu De, Circle Inspector of Police, Belda. During search police party recovered 27.01 kg Ganja from the house of the accused. On asked the accused failed to produce any valid license in support of running such business.
  - 4. Basirhat PS Case No. 98/19 Dated 27/01/19 u/s 21 (C) NDPS Act. Acting on source information a raid was conducted by police of Basirhat PS headed by SI Kali Sankar Saha on 27.01.19 in between 19.35 hrs to 21.45 hrs in a lonely place at Nakuadaha opposite of Ghoshkata under PS Basirhat, District North 24 Parganas and apprehended one accused person namely Suman Biswas @ Guye (25) s/o Lt. Jhantu Biswas of 1 No. Rajib pally, Uttarbagundi, PO Basirhat, PS Basirhat, District North 24 Pgs, who was moving suspiciously at a lonely place at there. During search one plastic jar containing approx. 10 liters of Codeine mixture have been recovered and seized from his possession. On being asked he failed to produce any valid license or any other valid documents in support of his possession of said Codeine mixture. Accordingly SI Kali Sankar Saha the said Codeine mixture under proper seizure list and arrest him.
  - 5. Ghoksadanga PS Case No. 33/19 Dated 26.01.2019 u/s 20(b)(ii)(c) of NDPS Act was started on the complaint of SI Rahul Talukdar, O/C Ghokshadanga Ps, that on 26.01.19 at 14.05 hrs, acting on a secret source information, he along with his team detained one truck bearing No. PB11CF/9926 that was coming from Pundibari side at New Changrabandha Naka point at around 14.35 hrs. On interrogation, the driver and other inmate i.e. 1) Ranbir Yadav s/o Kari Yadav of Afjalpur, PO Serbela, PS Salkhua, District Saharsa, Bihar (2) Jagtar Singh s/o Nirmal Singh of Sarla, PS Ghanor, PO Ghanor District Patiyala, Punjab confessed that on the top of the driver cabin some packets are stocked, the articles (packets) contain of Ganja for whose possession he failed to produce any documents. On search the packets were then found. The articles total weighing 107Kg and 55 grams of ganjas were seized under proper seizure list.

- 6. Mallarpur PS Case No. 21/19 Dated 24.01.19 u/s 20(b)/29 of NDPS Act. On 24.01.19 in between 17.05 hrs and 18.40 hrs acting upon source information he along with force of Mallarpur PS apprehended (1) Sk Kiran (23) s/o Sk Danesh of village Kalyanpur PS Sainthia, District Birbhum (2) Sk Ripan (19) s/o Sk Ser Ali of Do at near Gadadharpur Bazar. On searched in presence of BDO Mayureswar- II and recovered the following articles viz 25.200 kgs. of substance said to be Ganja.

Ghoksadanga PS Case No. 26/19 Dated 23.01.2019 u/s 20(b)(ii)(c) NDPS Act was started on the complaint of SI Ashok Majumder of Ghoksadanga PS Coochbehar against Prallad Barman s/o Gobinda Barman of Barodoba, PS Falakata, District Alipurduar that on 23.01.129 around 14.25 hrs, acting on a tip off, he along with his team detained two persons who identified themselves as noted above in a motor cycle near Fulbari High School with three different coloured articles and on perusal they confessed that the articles (packets and sack) contains Ganja for whose possession they failed to produce any papers. On interrogation, they stated that they have came from Kalabari side after purchasing Ganja to transport the same to Dhupguri and Kheti side for clandestine disposal for earning huge money. Accordingly, as per procedure and in presence of Ex. Magistrate, the following articles were seized (1) One Red Colour Apache Motor cycle bearing Reg No. WB 70 K 2983. (2) Three packets containing ganjas total weighing 31.450 Kgs.
- 8. Khoribari PS Case No. 21/19 Dated 22.01.2019 u/s 21(c)/22(c) of NDPS Act, 1985 has been started over the written complaint of SI Somen Biswas of Khoribari PS to the effect that on 22.01.2019 at about 02.35 hrs the complainant along with force, had been to Dudhgate More, Panitanki, under Khoribari PS and apprehended three persons, namely (1) Gopi Barman (24) s/o Sakalu Barman of Gandagoljote, Sabji Marker, PS Khoribari, (2) Pranab Barman (23) s/o Ramesh Barman of do and (3) Buddha Deb Sharma (50) s/o Naren Deb Sharma of Dhadarpath, Anantpur, PO Mudafat, PS Kaliaganj, District Uttar Dinajpur and recovered 1.229 Kgs of deep brown colour substance suspected to be Charas, cash Rs, 11,600 and one motor cycle without any number plate from their possession. On demand the accused persons could not produce any valid documents in respect of the articles in their possession and accordingly the complainant arrested the accused persons and seized the above mentioned articles.
- 9. Raninagar PS Case No. 48/19 Dated 21.01.19 u/s 21 (c)/29 NDPS Act has been registered on the complaint of SI Sonu Kumar, Coy Comdr. 117 Bn BSF, BOP Rajanagar under PS Raninagar that on 21.01.19 at about 07.30 hrs BSF party duty at BP No. 158/M of BOP Rajanagar and found that one person carried some articles then BSF party chased and arrested him namely Nejarul Sardar (32) s/o Farijulla Sardar of Ramchandrapur, PS Raninagar and seized 192 bottles of phensedyl from his possession.
- 10. New Jalpaiguri PS Case No. 48/19 Dated 19.01.19 u/s 20(b)(ii)©/23© of NDPS Act has been registered over the written complaint of SI Diptajit Dhar of NJP PS, SPC to the effect that on 19.01.19 at 18.55 hrs in pursuance of secrete source information arrested two persons namely 1) Mojidul Rahaman @ Selim (20) s/o Lt. Abu Bakkar Siddik of Paschim Dhantala, PS. NJP, 2) Safikul Md (22) s/o Lt. Mojiuddin Md of Sitaguri, PS NJP and seized 26.400 kgs of Ganja and one Motor cycle having Reg. No. WB 74 AK/6691 at Murder more. They were carrying the Ganja in the said Motor cycle for transporting the same somewhere in other state for their wrongful gain. Accordingly, he seized the same in presence of Sri Achinta Gupta, ACP (East-II), SPC and arrested him.
- 11. Dinhata PS Case No. 37/19 Dated 18.01.19 u/s 21(C) NDPS Act was started on the complaint of Ashok Kumar, OCP Coy Commander, A Coy, 38 BN, BSF of BOP Gitaldah, PS Dinhata, CBR against Rajjak Ali s/o Fayjar Rahaman of Jaridharla, PO Gitaldaha, PS Dinhata, CBR to the effect that on 17.01.19 at 17.40 hrs the above noted accused Rajjak Ali was carrying LPG cylinder with 140 bottle of phensedyl at that time the BSF party of Gitaldah BOP who were performing duty at checking point no. 19 near BP No. 927/5-S and recovered 140 bottle of phensedyl. However, accused Rajjak Ali fled away.

recovered (1) One transparent plastic packet containing 08 (Eight) grams (Apporx) of Heroin, (2) Cash Rs. 890/- (3) One blue and white color Nokia (Keypad) mobile phone having SIM No. 9091738873, IMEI No. 353210033383637 and (4) One black color plastic bag from his exclusive possession. Boxirhat Ps case no 04/19 Dated 14.01.19 u/s 20[b][ii][C] of NDPS ACT was started on 13. the complaint of SI Maloy Bose, IC Rampur Jorai Police Camp, PS BXT, CBR against 1. Nagindra Kumar Ray @ Lagindra [28] [Driver], s/o Jogi Ray of Kala Diara, PS Salimpur, District Patna, Bihar and 2. Akhilesh Kumar Ray [43], s/o Ram Naresh Ray of Ward No. 08, Diwantok, Tehrasia, PS Ganga Bridge, District Vaishali, Bihar to the effect that on the same morning acting on source information he detained one brand new Bronze Color Renault KWID vehicle without any Registration number on NH31C near Sankosh Road Bridge and found the two accused noted above inside the vehicle. On search of dickey of the vehicle, small packets wrapped with brown adhesive tape kept concealed were found emitting smell of ganja. On interrogation, they confessed it contained ganja and were transporting it to Patna Bihar. In due course and as per procedure, 54 packets wrapped with brown adhesive tape in total and all of them contained the suspected ganja weighing 60.400 kgs in total were seized. Khowas Sk of Ramakantapur, PS Jalangi and seized 100 kgs of Ganja from their possession. 17. Dubrajpur PS Case No. 09/19 Dated 11.01.19 u/s 15(C)/29 NDPS Act. On 11.01.19 at about 18.35 hrs., acting on a tip-off, police party of Dubrajpur PS held raid at Niramoy Morh on NH-14 and arrested one Najimul Hoda @ Ansari (52) s/o Saukat Ali of Kalikapur Kabiraj Para, PS Kaliyachak, District Malda. On search one Vehicle bearing Reg. No. WB-65B/0579 loaded with 11 (eleven) of polythene bags containing Broken poppy peels of Opium Poppy, Total weighing 500 Kgs (approx) was recovered and seized. 18. Hariharpara PS Case No. 17/19 Dated 11.01.19 u/s 21(C) NDPS Act has been registered on the complaint of SI Sujoy Roy of Hariharpara PS that on 10.01.19 between 20.45 hrs to 23.45 hrs in pursuance of source information he along with force held raid at Beltala More, PS Hariharpara and arrested one Saheb Sk (25) s/o Janip Sk of Rukunpur Balarampara, PS Hariharpara and 05 others and seized 15 liters of codeine mixture from their possession. 19. Pradhannagar PS Case No. 22/19 Dated 10.01.19 u/s 20(b)(ii)(C)/23(C) of NDPS Act has been registered over the written complaint of SI Raju sarkar of DD, SPC to the effect that on 28.09.18 a specific case has been registered over the written complaint of one Sandip Agarwal s/o Kishorilal Agarwal, Director of Kurseong Carrier Pvt. Ltd, Nehru Road, Khapara, Siliguri vide Siliguri PS case No. 725/18 dated 30.10.18 (.) During

investigation one Dipesh Trikorthri and Rahul Trikorthri both s/o Dilip Trikorthri of Thakurpari (Below Shani Mandir), PS & District Kalimpong have been arrested in c/w above referred case and taken to Police custody (.) During Police custody, on 29.12.18 in between 19.10 hrs and 19.55 hrs, as per leading statement of accused persons, the complainant and his team had been to 45/3 Bagha Jatin Colony, Ward No. 45 inside the vacant land of one Prodyuman Chowhan and seized five packets of different size weighing total of 27 Kgs 343 Grams of Ganja from one vehicle bearing Reg. No. WB 74 E/5555 (.) Accordingly, both the P.C accused were forwarded before Ld Court (.) Lalgola PS Case No. 43/19 Dated 10.01.19 u/s 21(C)/29 NDPS Act has been registered 20. on the complaint of SI Sanjib Mondal of Lalgola PS that on 10.01.19 at 10.35 hrs in pursuance to source information he along with force held raid at Modan Mohoan Roy B.Ed & D.EL. Ed College under Lalgola PS and arrested one Alam Biswas @ Alam Kabir (45) s/o Lt. Osman Biswas @ Ali of Natungram Chataidubi PS Lalgola and seized 08 liters of codeine mixture from his possession. Raninagar PS Case No. 20/19 Dated 06/19 u/s 21(C)/29 NDPS Act has been registered on 21. the complaint of SI Dev Kr.Chakrobarty of Raninagar PS that on 06.01.19 at about 14:05 hrs in pursuance of source information he along with force held raid at Godhanpara near primary School under Raninagar PS and arrested one Najrul Mandal (45) s/o Lt.Samsuddin Mandal of Dakshin Goribpur PS Domkal and seized 250 bottles of Phensidyl and 01 Black colour Glamour Motor cycle bearing engine no.JA06ERJGEL1960 from his possession. Jalangi PS Case No. 21/19 Dated 06.01.19 u/s 21(c)/29 NDPS Act has been registered 22. on the complaint of SI Surajit Mondal of Jalangi PS that on 06.01.19 at about 15.45 hrs in pursuance of source information he along with force held raid at Charkakmari Bridge More under Jalangi PS and arrested one Ukil Mondal (37) s/o Haroj Sk of Sahebnagar PS Jalangi and seized 09 Ltrs of Codeine Mixture from his possession. Baguiati PS Case No. 11/19 Dated 04/01/2019 u/s 21(C) Narcotic Drugs and Psychotropic Substances Act, 1985 on 04.01.19 at 21.45 hrs SI Susanta Kumar Ghosh of Baguiati PS, BDN PC producing accused person Beenit Jaiswal (35) s/o Vijoy Jaiswal of Block-B Chowdhury Apartment, Lokenath Park, PS Baguiati, District North 24 Parganas along with seized articles and submitted a typed suo-moto complaint to the effect that acting on creditable source information SI Susanta Kumar Ghosh of Baguiati PS held raid at the residence of Beenit Jaiswal mentioned above and recovered 208 bottles of Codeine Phosphate which was illegally stocked by Beenit Jaiswal for commercial purpose and failed to produce any documents in support of huge quantity of Codeine Phosphate. Subsequently said SI Susanta Kumar Ghosh seized the same and arrested the accused person. Farakka PS Case No. 19/19 dated 10.01.19 u/s 489B/489C IPC has been registered on 30. the complaint of SI Somnath Singha of Farakka PS that on 10.01.19 at 05.05 hrs in pursuance of source information he along with force held raid in front of Farakka Filling Station at New Farakka on NH-34 under PS Farakka and arrested one Kishor Sardar (32) s/o Ram Sardar of Bhabanipur, PS Farakka and seized Rs. 80,000/- (2000 X 40) of FICN from his possession. 31. Nowda PS Case No. 08/19 dated 10.01.19 u/s 489B/489C IPC has been registered on the complaint of ASI Debabrata Dey of Nowda PS that on 10.01.19 at about 19.35 hrs in pursuance of source information he along with force held raid at Gangadhari Bazar near Bank more and arrested one Faruk Sk s/o Nurul Islam of Pirojpur, PS Raghunathganj and seized Rs. 18,000/- (2000 X 9) of FICN from his possession. 32.
