Police Order No. 01 of 2018

**Sub : Raising of three Rapid Action Force (RAF) Battalions under
West Bengal Police**

1. West Bengal Police has proposed Government to establish three RAF Battalions to deal with law & orders situations with properly motivated force having right attitude, correct skills and adequate equipments in a concerted and professional manner.
2. Pending formal sanction order of Government three ad-hoc Battalions of RAF will be raised from the sanctioned strength and available resources of West Bengal Police. The three Battalions (RAF 1st Bn., RAF 2nd Bn. and RAF 3rd Bn.) will be raised at the locations noted in the table below :

These 3 Battalions will be converted to Regular Battalions on receipt of formal sanction by Government.

3. Objectives for raising RAF Battalions:

a) Primary:

- i) To tackle unprecedented law and order situations including communal violence,
- ii) To provide rescue and relief operation to the victims of such violence so that normalcy is restored promptly in the area.

b) Secondary:

- i) To provide rescue and relief operation during natural and man-made disaster;
- ii) For execution of large raids and search especially in built-up areas;
- iii) To provide Command, Control and Communication facilities in large scale-operations involving RAF as well as other police forces.

The rank and staff structure of the proposed RAF Battalions are explained in Annexure-I.

5. Each battalion will be provided with strength of vehicles / accoutrements / non lethal weapons / telecom equipments etc as explained in Annexure-II.

6. The training of the RAF Battalions will be organized on continuous basis in consultation with the Head of Armed Police.

7. Deployment Guidelines:

- i) RAF will not be deployed at a strength less than one section in field situation.

- ii) RAF will not be deployed for any routine duties.
 - iii) RAF will work under the operational control of the District Police / Commissioner of Police.
8. Commandant of each RAF Battalion will publish annual report highlighting different activities of Battalions which should include
- i) deployment of forces,
 - ii) training programmes conducted and undertaken by force and
 - iii) welfare activities.
9. DG & IGP, West Bengal may at any point of time revise, relax or repeal any of clauses of the police order as and when required.

Police Order No. 04 of 2018

In partial modification of police order no. 7 of 2013, the following revised police order is being issued regarding CIAT School of West Bengal Police.

Sub : Counter-Insurgency and Anti-Terrorism School of West Bengal.

- 1. Establishment of Counter-Insurgency and Anti-Terrorism School:** Temporary Counter -Insurgency and Anti-Terrorism School (CIAT) was set up in LWE affected States under a Plan Scheme of Govt. of India, Ministry of Home Affairs. In implementation of that Scheme, Govt. of India, Ministry of Home Affairs approved setting up of one CIAT School in the State of West Bengal vide letter No. 57/25/2009-Trg.III/BPR&D dt. 27/10/2010 of B.P.R & D., New Delhi. Accordingly, the only CIAT School of the State has been set up at E.F.R. Brigade Campus, Salua, Dist.- Paschim Medinipur with post-facto approval of the State Govt. conveyed in Home (Police) Deptt., Govt. of West Bengal Notification No. 5316- PL/HP/PB/2S-4/10(Pt) dt. 02/11/2012. The CIAT School at Salua, Dist.- Paschim Medinipur has become functional with effect from 01/9/2011.

The School was a temporary one set up under 11th Five Year Plan and continued in 12th Five Year Plan. Govt, of India provided fund for (i) Raising temporary Infrastructure, (ii) Upgradation of Infrastructure, (iii) Upgradation of Equipment & (iv) Payment of Trainers remuneration as per Orders/ Guidelines issued by B.P.R&D., New Delhi from time to time. As decided by M.H.A., Govt. of India, after 31st March, 2017, onus of running the School lies with the State. State Govt. will meet all expenditure and provide Administrative support. Training and administration Policy will be guided by recommendations of Board of Officers to monitor Functioning of CIAT from time to time as approved by Govt. of West Bengal.

- 2. Objective of Counter-Insurgency and Anti-Terrorism School:** The main objective of the CIAT School is to impart training in Counter-Insurgency Jungle/ Urban Warfare and Anti-Terrorism Operations to the members of Police Force (from Constable to Sub-Inspector in both Armed & Un-Armed Branch) which, followed by in-service training and Refresher Course, will provide the Police personnel of State a depth in responding effectively to the threats originating from the extremists.
- 3. Framework and Policy Guidelines:** The school will impart training to the Police units of the state to combat Extremist, Terrorism, Jungle/ Urban Warfare

and to combat the Left Wing Extremism. It will build necessary capacity by way of training in intelligence gathering, operational preparedness, handling of latest weaponry and other technologies as force multiplier for enhancing the operational tactics and skills of the West Bengal Police. It will help in creating force capabilities to implement the future strategies being conceived to deal with extremism of any kind. It will maintain close liaison with similar specialized training centres in the neighbouring states in general for inter unit enhancement of resources and skill sets by mutual sharing of training materials, case studies and trainer visits to learn about their training methodologies subject to necessary approval of DG & IGP.

The Various police units will supply case studies and lessons learnt from the field operations which could then become a basis of training of the future batches. These documents will act as training repository for counter LWE training. Principal CIAT School shall send a team of instructors to study the operational field areas for purpose of preparation of case studies for imparting training.

The CIAT School will update its lessons in operational tactics drawing on the experience of the Police Units from the fields so as to fit in the requirement of typical geographical area prevailing in the extremism affected districts. They will also obtain CDs/ Films, create a library of books/ CDs for updating knowledge on Counter Insurgency skills

4. Nodal Officer of the School: Additional Director Genl. & Inspector General of Police (Welfare), West Bengal has been nominated by the Director General & Inspector General of Police, West Bengal as 'Nodal Officer - I' in respect of the CIAT School at Salua, Paschim Medinipur vide G.O. No. 3302 / PL / HP/ BMC /14 M -94/14 dated 28.07.2016 to

- i. Supervise and provide guidance & oversight in the matter of imparting uninterrupted Training in the School and
- ii. To Co-ordinate with Government and Home department in connection with matters relating to CIAT School

ADG & IGP (AP) WB may be nominated as Nodal Officer -II

- i. Co-ordinate with West Bengal Police Directorate in all administrative matters of the School.

5. Board of Officers to Monitor functioning (including Selection of Trainer/ Instructors) of CIAT School, Salua: There will be a Board of Officers to Monitor functioning (including Selection of Trainers / instructors) of CIAT School, Salua to monitor functioning of the School, to select Trainers for the School and Devise Syllabus for the School. The Board originally constituted by the Director General & inspector General of Police, West Bengal vide

W.B. Police Directorate Memo. No. 173-ADG (Wel)/ 16 dtd. 15.06.2016 has been modified vide subsequent orders, as mentioned below :

6. Administrative Set up:

Principal: There will be a Principal of the CIAT School as Administrative Head of the School. Commandant, E.F.R., 1st Bn., Salua, Paschim Medinipur has been declared by State Govt, as the Principal of the CIAT School at Salua, Paschim Medinipur vide G.O. No. 2447-PL dt. 12/6/2012.

Principal will act as Drawing and disbursing officer for CIAT School. He will act as Administrative Head who will be the nodal link between the Board of Officers to Monitor Functioning of CIAT School. He will be responsible for drawing up of training calendar and submission of same to the Board for approval. He will be responsible for sending timely proposals to the Board in connection with recruitment/ renewal of the Contractual trainers of the CIAT. His foremost responsibility would be to build up a core team of instructors, guide them and evaluate their performance and assign tasks. He will be the disciplinary authority for the Trainees/Trainers and other staff of the CIAT. He will have to look after the creation, augmentation and maintenance of training infrastructure and course contents. He shall submit a course report at the end of each course for the consideration of the Board.

All proposals for expansion, modernization, special assistance for the CIAT shall be prepared by him and will be submitted to the Board through ADG Armed Police for kind consideration and onward transmission to government for approval.

Vice-Principal: Principal CIAT School may, if required, submit to the Director General & Inspector General of Police, West Bengal a proposal to appoint an Assistant Commandant as the Vice-Principal of the School to assist him in the day to day administrative work. He will be responsible for monitoring day to day functioning of the school. He will supervise the training process by being actively involved in the process from the morning roll call to light out. He is supposed to supervise the outdoor training with monitoring of performance of the trainees and making necessary course corrections for minimising failures in training. He will monitor the quality of trainers by random inspections of the classes and taking feedbacks. He will give the vital inputs which will become basis of renewal of the contractual trainer's services. He is supposed to maintain highest level of discipline and orderly conduct of the trainees. He will also look after the day to day welfare of trainees/trainers. He will look after the day to day administrative work of the office of CIAT and other such responsibilities as assigned to him by the Principal CIAT.

7. **Trainers:**

Supervisor - The CIAT School will also have a Supervisor to supervise the work of the Trainers. The Supervisor should be an ex-Army or ex CAPF or Ex West Bengal/ Kolkata Police Officer in the rank of Colonel / Lt. Colonel / Commandant /Captain/Major/ Deputy Commandant/ Assistant Commandant, having proficiency in the field operations in Counter Insurgency and Jungle Warfare, Leading Combat Teams, functional experience with training institutions imparting training in Counter Insurgency and related fields. The Supervisor should not be more than 62 years of age. The Supervisor will be selected by the Board of Officers to Monitor functioning (including Selection of Trainers / Instructors) of CIAT School, Salua and appointed by the Principal, CIAT School on contract basis for a year or more. Remuneration payable to the Supervisor may change subject to approval of Home Department Govt. of West Bengal.

He shall play the role of Chief Drill Instructor, responsible for Drawing up of weekly time table for the course, keeping up the discipline and morale of the course to the highest of standards. He will be responsible for conduct of all outdoor exercise including jungle camps. He will design the individual exercises which the trainees will undergo and fine tune them by keeping a record of the exercises and learning points from them. He will also be responsible for maintenance of discipline off field and in the barracks of the trainees.

8. Contractual Trainers JCO / Subedars and NCO/Havildar

These Trainers are to be ex-Army or ex-CAPF/ working or retired police personnel with relevant experience as Trainer / Instructor / Field experience in Counter Insurgency and Anti-Terrorism subjects at any Army / CAPF Training Centres /Field units especially in the Centres which impart training to personnel in Anti-Terrorism/Jungle Warfare and Weapons & Tactics. Trainers should not be more than 62 years of age. The Trainers will be selected by the Board of Officers to Monitor functioning (including Selection of Trainers/ Instructors) of CIAT School, Salua and appointed by the Principal, CIAT School on contract basis for a year or more. The monthly Remuneration of trainers will be decided by the Board with the approval of Home Department, Govt. of West Bengal. The Trainers will be responsible for conduct of lessons as per the weekly time table. They will be assigned the squads of trainers and will act as DI/ADI for their respective squads. They will be responsible for performance/ Discipline of their respective squads and the members therein. They will ensure development of skills, team spirit and the highest level of morale and discipline in their respective trainees. Govt. of West Bengal has created 06 posts of JCO/Subedar & 12 posts of NCO/Havildar with effect from 01/9/2011 and 01 post of Supervisor with effect from 01/10/2011 for the CIAT School at Salua up to 31/8/2019 vide G.O. No. 3494-PL /HP/N / BMC /14 M-148-13 dated 11.08.2016.

9. Trainees

The counter insurgency and anti-terrorism operations are fraught with serious hazards and it is essential that trainees have a high degree of fitness and mental alertness, it is very important that they undergo a rigorous disciplined training at CIAT. Trainees will be Police personnel not above 35 years of age in the Ranks of Constable / A.S.I. / S.I. (both Armed & Un-armed Branch) from all the Districts / Battalions / Units to be selected by the Additional Director General & Inspector General of Police (Law & Order), W.B. No. of Trainees to undergo a course of Training should be 150-200 and No. of Trainees to be drafted from the Districts /Battalions / Units for a Course of Training will be allocated by the Additional Director General & Inspector General of Police (Law & Order), W.B. the number of trainees nominated shall never be below 4 SI/ASI and 16 Constables/Junior Constables per unit. A 2-week long pre-course training should be arranged in the selected Districts/ Battalions / Units for the Trainees to ascertain the Physical efficiency, Endurance level & Basic knowledge before sending them for training in CIAT School. Superintendents of Police/ Head of Police units will ensure adherence to the guidelines of trainee selection for avoiding injuries and return of trainees. CIAT school will provide for training equipment and other logistics items, arms and ammunition for training along with free lodging and boarding. Trainees who will successfully complete training will be entitled to wear

CIAT logo as approved by DG&IGP WB vide memo no 2342- EQ-/CL/EQ/CL -117/13 dated 13/09/2013 of IGP(O) West Bengal on uniform as a mark of specially trained personnel.

10. Training Calendar:

The Principal, CIAT School, Salua, Paschim Medinipur in consultation with the Nodal Officer I & II of the School shall prepare an Annual Training Calendar and submit the same by last week of January every year through Training Branch to the Director General and Inspector General of Police, West Bengal for approval. It should be ensured that a minimum of 5 (five) courses of training is held in every year.

11. **Training Course:** Duration of a Training Course will be of 06 weeks having 36 working days. 10 weeks consisting of 60 working days, and 12 weeks consisting of 72 working days.

Training will be imparted as per Syllabus prepared, furnished and approved by Board of Officers to monitor functioning of CIAT School. Besides the training as per syllabus following exercises will also be emphasized —

1. Strategy and tactics for dealing with left wing extremism.
2. Collection, collation, analysis and dissemination of intelligence, both human and technical, on left Wing Extremism.
3. Information about the hardcore cadres as well as frontal organizations including civil liberties groups.
4. The modalities of collection of intelligence will also include cultivation of agents & sources, appointment of special Police officers and conducting open and secret enquiries and surveillance.
5. Guidance about keeping proper coordination with IB, WB to the anti LWE sections of the Districts Intelligence Branches and also to the district Police in general
6. Planning of operations as well as in the debriefing sessions of operations.
7. Conducting Psychological operations against the unlawful and violent activities of Left Wing Extremists.
8. Participation of Trainees after completion of training in Jungle operations for minimum 2 weeks to get practical experience.
9. Exposure to cyber terrorism and urban warfare Training.
10. Weekly Firing Practice.
11. Night Firing Practice.
12. Disposal of IEDs under supervision of IED experts.
13. Weekly Night Route Marches with Compass / GPS.

14. Two-week refresher Course once in two years for all those who have undergone Training in this School.

No Leave shall be granted to the Trainees during the Training Period except on special /compassionate ground duly considered by the Principal, CIAT School, Salua, Paschim Medinipur.

The Principal, CIAT School, Salua, Paschim Medinipur shall prepare a Standing Order, of Dos & Don'ts for the Trainees who shall be briefed accordingly in the inaugural Class of Training. Barrack and Mess Rules should also be strictly enforced.

An examination shall be held in the last week of the Training Course. The Principal, CIAT School, Salua, Paschim Medinipur assisted by the Vice-Principal and Supervisor of the School shall arrange for the examination and nominate the question-papersetter(s) & examiner(s) for each subject from among the Trainers. Result of the examination shall be declared by the Principal, CIAT School, Salua, Paschim Medinipur on the concluding day of the Training Course.

12. Training Cost

The details of cost of Training per trainee for the three different Courses conducted by CIAT School, Salua vide GO No.290-sanction/HP/N/BMC/14M-213/13 dated, Howrah, the 22nd July 2016.

The trainees will be provided training in the following weapons with amount of training ammunition scale provided against each weapon as per the arming policy and training guidelines.
