4. Important detections made by West Bengal Police:-

i) **Ashoknagar PS Case No. 382/24 dt 28.06.2024 U/S-417/418/420/468/471/294A/34 IPC & section 4 of Lottery Ordinance Act & section 7(3) of Lottery Regulation Act** has been started on the basis of the suo moto complaint of Inspector Tuhin Das, DDI Barasat DD, CID WB to the effect that on 28.06.24 at 16.45 hrs he received a source information regarding conducting fake lottery business for a long time at Guma Rabindra Bazar under Ashoknagar PS. Accordingly as per the instruction of superiors he along with officer and force had been to Guma Rabindra Bazar under Ashoknagar PS by Govt. Vehicle bearing registration no. WB 24AM 7946 vide Barasat DD GDE No. 106/24 and as per source information raid was conducted at the shop of Kamallesh Baidya (52yrs) S/o Krishnakanta Baidya of Bara Bamonnia, Shantinagar under Ashoknagar PS and he disclosed his identity and search was conducted at the shop of Kamallesh Baidya namely “BAIDYA AGENCY” and he was caught in red handed with huge fake lottery namely “KANCHENJUNGA VENUS, BHUTAN STATE LOTTERIES”. Then Inspector Tuhin Das interrogated him and he admitted that he and his son namely Kallol Baidya S/o Kamallesh Baidya of Bara Bamonnia, Shantinagar under Ashoknagar PS has been doing fake lottery business for long time and has earned a lot of money by defrauding the government. He seized the “KANCHENJUNGA VENUS, BHUTAN STATE LOTTERIES total-27800pcs (Twenty seven thousand eight hundred), ii) 2 pices of USB Keyboard, one AOC Monitor, 2 nos of CPU, 2 pcs of Mouse, 2 pcs of Monitor, 1 pcs of Keyboard, 1 pcs of UPS, 1 pcs of Printer, One mobile phone of Realme UI 11X5G Model No. RMX3785 IMEI No.

864816068404999 & IMEI No. 864816068404981 and Cash of Rupees 2540/- (Two thousand five hundred forty only) in presence of police personnel under proper seizure list and then arrested accused Kamalesh Baidya (52yrs) S/o Krishnakanta Baidya of Bara Bamonia, Shantinagar under Ashoknagar PS at 19.50 hrs for conducting fake lottery business. It is to note that when we reached at the shop of Kamalesh Baidya and talked with him regarding above matter suddenly his son Kallol Baidya fled away from their shop. Hence the case was started.

ii) Khanakul PS Case No - 336/2024 Dt. - 28.06.2024 u/s 294A/ 417/418/420/468/471 IPC and Section 4 of lottery Ordinance act & section 7 (3) of lottery Regulation Act. On 28.06.2024 at 15.45 hrs received a written complaint from SI Sujoy Kr Sinha of Hooghly DD, CID, West Bengal to the effect that, on 28.06.2024 at 08.05 hrs received information from my reliable source that the aforesaid person is selling fake lottery ticket at Ramnagar Bazar near Bas-Stand under Khanakul P.S area. After that complainant along with force reached at Ramnagar bazaar near Bus-Stand under Khanakul PS found the aforesaid person started to flee away after noticing the police van, accordingly complainant managed to apprehend the aforesaid person and recovered some tickets and found he has been selling different type of lottery tickets which are seem to be fake. On such basis the above noted case has been started. Arrested one namely Sudip Pandit (32) S/O- Swapan Pandit of Vill+PO+PS-Khanakul, Dist- Hooghly.

iii) Suri PS Case No-336/24 dtd-28.06.24 u/s 417/418/420/468/471/294B/34 IPC & Section 4 of Lottery Ordinance Act & 7(3) of Lottery Regulation Act: On 28.06.24 at 11.35 received a complaint from Sanchayan Banerjee, Inspector of Police, DDI of Birbhum DD, CID, WB to the effect that on 28.06.24 at 06:15 hrs as per source information he & his accompanying force apprehended one accd person Amal Garain, S/o Lt. Mantu Chandra Garain, of Nuraipara, near Rashmandir, PO: Suri, PS: Suri, Dist. Birbhum from R.T Girls School more under Suri PS area and recovered and seized some fake lottery tickets from his possession. He also alleged that the said arrested accused person and Abhijit Chatterjee @ Santosh and Sk Mustafa both of Suri also are involved in this illegal business and was selling the said fake lottery tickets for their personal gain and also for obtaining prize money by fraudulent means and loss of huge Govt. revenue.
