



i) AJC Bose Botanic Garden PS Case No : 209/24 Dated 14/11/2024 US 143/93/98/137 IPC &75/81 Juvenile Justice (Care and Protection of Children) Act, on 10.11.2024 received a written suo-moto complaint from LSI. Shreyashi Bagchi of AHTU, CID, WB against (1).Manik Halder (38 yrs) s/o Lt. Ram Chandra Halder of B/8/32, Diamond Park, PO- Joka, PS- Haridebpur, Kolkata, & (2) Smt. Mukul Bag @ Sarkar (35 yrs) d/o Prabhash Sarkar w/o Manik Halder of B/8/32, Diamond Park, PO- Joka, PS- Haridebpur, Kolkata and also of Bagpota, Sarsuna, Dist-South Pgs to the effect that on 10.11.2024 the complainant along with other officers and force had been to Shalimar railway station parking stand on the basis of an information that some persons involved in trafficking of new born babies would hand over a new born female baby at an exchange of four lakhs rupees. Today at about 05.45 hrs when the above noted persons arrived at Shalimar railway station to deliver the trafficked new born female baby to the decoy customers, they were caught red handed. The accused persons were detained and interrogated wherein they disclosed their identity as (1).Manik Halder (38 yrs) s/o Lt. Ram Chandra Halder of B/8/32, Diamond Park, PO- Joka, PS- Haridebpur, Kolkata, & (2) Smt. Mukul Bag @ Sarkar (35 yrs) d/o Prabhash Sarkar w/o Manik Halder of B/8/32, Diamond Park, PO- Joka, PS- Haridebpur, Kolkata and also of Bagpota, Sarsuna, Dist-South Pgs. The aforesaid new born female baby said to be born on 08.11.2024 was recovered from their possession. Hence the case.

ii) Chandannagor Cyber Crime PS Case No : 53/23 Dated 01/08/2023 US 419/420/406/120B IPC &66D Information Technology Act, The fact of the case is in brief that on 01.08.2023 at 17:15 hrs one Samik De, S/O Late Manotosh Dey of 54/O S.C. Chatterjee Sarani, P.S- Serampore, Hooghly, Pin- 712203 came to PS and submitted a written complaint to the effect that he has been trading in Bitcoin with an organization named CAE. The company made an agreement to join a profit plan where he will get a profit of his investment. In good faith he invested a total amount of Rs. 42,97,687/- and when he wanted to release it from the said organization they told to pay 25% commission of his profit separately. Desperately then he paid the profit percentage by taking loans from banks, GPF, PPF, LIC etc. But when he paid the profit percentage then they again asked to pay 10% tax to release his money and this time he arranged it with great difficulty. After the payment of the tax they again asked to pay money for security deposit amount of 10000 USDT. Then he realized that it was a complete trap and he has been cheated by this organization. Over the written complaint of the complainant the above noted case has been started.
