Rambir Sardar of vill- Garhpara, Po-Berachampa, PS- Deganga, Dist- North 24 parganas.

B) Purba Medinipur Cyber Crime PS Case No.42/22 dtd.27.07.2022 u/s-406/416/420/120B IPC adding section 413 IPC. On 14.03.2023 morning a raid was conducted by Officers & forces of East Medinipur DD in c/w the investigation of the above referred case and the prime accused namely Roma samanta(24) d/o- Kuntal samanta of 17/27A Dakshindari Road, South Dum Dum, PS - Lake town Kolkata-48 A/P-17/38 Dakshindari Road.

C) Golabari PS Case No.09/23 dated-09/01/2023 u/s-370 IPC & 13/14 foreigners Act. The fact of the case in brief on 09/01/2023 at around 13.05 hrs in pursuance of a secret source information, SI Pratik Subba along with officers & men of Golabari PS, HPC arrested one Sudip Das and 9(nine) Bangladeshi persons and recovered 03(Three) minor Bangladeshi from Parking Stand No.03 near Howrah Railway Station.
