

Anti Human Trafficking Unit of CID, WB held raid at Kolkata Airport leading to source information and rescued two young Bangladeshi girls aged 25 yrs and 27 yrs. During raid they also arrested two traffickers namely Dipu Mondal (39 yrs) @ Amit and Achintya Majumder @ Poltu (29 yrs). It is revealed that, it is a case of international human trafficking where the victims were allured over the false promise of providing them good jobs. Fake ID cards of the girls and other incriminating materials were seized from the traffickers. The fake ID Card maker Tarun Kanti Majumder(47yrs) has also been arrested. Dipu Mondal procures girls from Bangladesh, prepares their fake IDs with the help of Tarun and then traffics them to Bangalore.
