



### 4. Important detections made by West Bengal Police:-

**1. Galsi (Purba Bardhaman) PS Case No. 380/23 Dt. 24.06.23 U/S-379/411/414/120B IPC. And 15(2)/15(4)/16 of The Petroleum and Minerals Pipeline Act 1962 and subsequent amendment, 2011 and section 3/4 PDPP Act and 3/4 Explosive Substance Act.**

The fact of the case in brief is that in the last couple of months IOCL noticed pressure drop to Haldia-Bolpur section of PHBPL pipeline. They were searching to detect the reason for pressure drops. Finally on 24.06.2023 afternoon pilferage was detected in the midst of the open field at Belgram Mouza under Galsi PS by the inspection team of IOCL. There is a Chemical Factory (Swami Devananda Chemicals) adjacent to approx 300 mtrs from the

IOCL pipeline. After thorough searching a trench mark from the boundary wall of the said factory towards the IOCL pipeline was noticed. Accordingly the inspection team of IOCL started excavation with JCB immediately following the trench mark. After excavation one illegal valve tapping from the mainline of IOCL has been detected; which directly goes into the chemical factory. After then with the help of Galsi PS the inspection team of IOCL entered into the premises of the said Chemical factory & a valve fitting with hose was found inside of a shed. Total 150 nos empty 40 Ltrs Jar were recovered among them 06 nos jar were filled with crude oil of Indian oil. The owner of the factory along with others laid a pipeline from IOCL crude oil pipeline to his factory premises and had stolen the crude oil. Arrested 1. Rs-804625/- (Eight lakh four thousand six hundred twenty five) in different occasions in different way. The transaction was occurred in between 27.09.2021 to 30.06.2022. Later the complainant came to know that, he has been cheated by the fraudsters and unknown miscreants by fraudulent means. Hence the case started at Mathurapur PS. Arrested 1. Subsequently the complainant came to contact with Priya Agarwal (7077282731) and Gourav Munjal (8002220266) through WhatsApp. They directed the complainant for investment through their Apps and as per their direction he transferred total Rs. 38,19,000 /- to their bank account for buying IPOs. But later he realize that he had been cheated from those unknown persons. A complaint has been filed on the National Cyber Crime Portal vide Acknowledgement No. 23201250003151. Over this matter over this written complaint a case was initiated, and ASI Kalyan Mukherjee took

charge of the investigation. Pursuant to the Hon'ble High Court's directive, CID West Bengal assumed control of the investigation vide Org no 471/CS dated 15.05.2025.
