

In the instant case the accused person namely Bhombal Mandal (31 yrs) s/o Lt. Dhananjoy Mondal of Gayenerchak P.O- Gopalganj hat, P.S. Kultali, South 24 Parganas, started living at the rented house of Biman Mondal S/O Late Ram Pada Mondal of Sonarpur Milonpally, Ward No. 13, under PS Sonarpur, Baruipur Police District along with his wife Tumpa Mandal. After one month, the accused Bhombal Mandal left the house alone leaving all his house hold articles there. On 24.06.2023 morning, the police of Sonarpur PS, CID, Ld. Magistrate and parents of Tumpa Mandal came to the said rented house of Bhombal Mandal and on being identified by the accused person recovered the skeleton and bones of Tumpa Mandal from the Septic Tank situated behind the rented room of Bhombal Mandal. As per the confessional statement of the accused Bhombal Mandal, he had killed his wife Tumpa Mandal and had thrown her dead body in the Septic Tank to conceal the evidence. Tumpa's parents identified the skeleton and bones as of Tumpa by identifying the 'SANKHA' found with the bones.
