



Alternative Medical Council is not a recognized Council and qualification(s) awarded by them are not recognized or not legal documents. A news paper cutting displaying the news that alternative Medical Council are not recognized and the persons to be admitted in their own responsibility in the such courses and also an order of the Union Government of India restricting admission in the alternative courses. Over this written complaint the instant case was started.

As per order of Honb'le High Court Calcutta the case was controlled for investigation by CID, WB on 24.08.16. Officers of CID, WB proceeded to Goa for holding raid and arrested 1 accused person namely Swagat Mallick (28) s/o Lt. Bande Nehaz Mallick of village Guskara, Chaltapara, PS Ausgram, Burdwan from Amzad Khan, LIG 350, Gogal housing board, PO+PS Margaon, Town PS, Goa and rescued one minor girl of Kirnahar Purba patty, PS Nanoor, Birbhum.
