This case under reference was started when a written complaint was received from Shri Tushar Kanti Mondal, Deputy Director (Mktg) C.G.O Complex 3rd MSO Building, DG Blook, Saltlake City, Kol-64 and forwarded to I/C Khardah Ps for starting a case U/s 7 (i) (a) (ii) of Act X/55 against M/S Agarpara Jute mills Ltd, Ps- Khardah, Dist- North 24 Parganas for violating of the provision of Jute & Jute Textiles Control Order, 2000. Accordingly I/C Khardah Ps started Khardah Ps Case No. 96/16 dated- 05.02.16 U/s 7 (i) (a) (ii) of Act X/55 against M/S Agarpara Jute Mills and as per endorsement SI Muktipada Das, EB, WB took up its investigation the case.

(B) Ref : Bally Ps Case No. 19/16 dated- 05.02.2016 U/s 7(i) (a) (ii) of Act X/55

This case under reference was started when a written complaint was received from Shri Tushar Kanti Mondal, Deputy Director (Mktg) C.G.O Complex 3rd MSO Building, DG Blook, Saltlake City, Kol-64 and forwarded to I/C Bally Ps for starting a case U/s 7 (i) (a) (ii) of Act X/55 against M/S Bally Jute mills Ltd, Ps- Bally, Dist- Howrah for violating of the provision of Jute & Jute Textiles Control Order, 2000. Accordingly I/C Bally Ps started Bally Ps Case No. 19/16 dated- 05.02.16 U/s 7 (i) (a) (ii) of Act X/55 against M/S Bally Jute Mills and as per endorsement SI Nikhil Chandra, EB, WB took up its investigation the case.

(5) Interesting detections by CID, West Bengal :-

Ref: Chinsurah Ps Case No. 468/15 dated_ 22.09.15 U /S_ 328/379 /34 IPC.

The fact of the case in brief is that on 11.06.2015 at 22.20 hrs. Shri Biswajit Dhara S/o-Late Subal Ch Dhara of Benabharui Uttarpara, Ps- Chinsurah, Dist.- Hooghly submitted a written complaint at Nabadwip PS against Rahul Bose and others to the effect that on 10.06.2015 at around 13'30 hrs one Rahul Bose hired one Maruti suzuki Ertiga (new) Car bearing No. WB- 09TC -104 from "Gangamoni Trading", Basanta Bagan, Chinsurah, Hooghly for Mayapur under ps- Nabadwip, Dist.- Nadia and back. After arrival at Mayapur, Nabadwip, driver cum- owner Shri Subash Mondal parked his vehicle at parking place where he was offered "Fruity" by said Rahul Bose and after consumption he became senseless. Accused Rahul Bose and his associate stole away the car leaving driver - cum- owner Shri Subash Mondal on road side in senseless condition. Over the incident Nabadwip Ps case No.239/15 dt.11.06.15 u/s-328/379/34 IPC was started on the basis of written complaint of Shri Biswajit Dhara and later on the instant case has been further recorded at Chinsurah Ps as per order of Ld. C.J.M., Hooghty dated- 22.09.2015.

Investigation of the case was assumed by CID WB.

The case has been detected. CID officers Arrested accused Arijit Roy @ Puchi @ Rahul Bose and gang-leader / Kin-pin of this InterState car Lifting Racket Shyamalendu nay @ Shyamal @ Chhotka @ Maloy @ Ganesh @ Dada etc. They confessed their guilt and stated that accused Arijit Roy @ Puchi @ Rahul Bose disclosed that hired one Maruti Suzuki Ertiga (new) car bearing No.WB 90TC 104 and boarded the car with their

associates from Rabindranagar Govt. Qtr. GT Road, Chinsurah, Dist.-Hooghly to Mayapur, Nabadwip, Dist- Nadia duly driving by driver-cum-owner Shri Subash Mondar. After arrival at Mayapur, Nabadwip, shri Subash Mondal parked his vehicle at parking place where they were offered "Fruity" by accused Arijit Roy @ Puchi @ Rahul Bose and after consumption he became senseless. Then accused Arijit Roy @ Rahul Bose and his associate stole away the car leaving driver-cum-owner shri subash Mondal on road side in senseless condition. Thereafter they picked up their gang-reader Shyamarendu Ray @ Shyamal and went to Falakata, Jalpaiguri where they handed over the stolen car to other part of their gang. In course of interrogation they also added their associates namely Animesh, Tanmoy, Babu, Sandip & others lifted about 10/12 medium vehicles like Scorpio, Ertiga, Maruti swift Desire, Bolero, Tata sumo etc' from Chinsurah' Kalyani, Bolepur, Maldah, Raigunj, Sonarpur & other places of West Bengal and disposed the lifted stolen vehicles in Assam & Nagaland area under the leadership of Kin-pin of this Inter state Car Lifting Racket namely Shyamalendu Ray @ Shyamal @ Chotka @ Maloy @ Ganesh @ Dada etc.

T.I. Parade of accused Arijit Roy @ Puchi @ Rahur Bose and Shyamarendu Ray @ Shyamal @ Chotka @ Maloy @ Ganesh were done at chinsurah sub-correctional Home and they are identified by the victim & owner-Cum-Driver of Maruti suzuki Ertiga (new) Car bearing No. WB-90TC-104 & three others. Some important documents were seized and it is found that accused persons, Shyamal, Babu, Animesh booked a room mentioning Mobile No.9051369578 of Arijit Roy @ puchi @ Rahul Bose (user) as their own and staying there before lifting the Car i'e. Maruti Suzuki Ertiga (new) Car bearing No. WB 90TC- 104 and also seized suspected drugs (Tabtets) from the house of Shyamatendu Ray @ Shyamal @ Chhotka @ Matoy @ Ganesh.

Shyamalendu Ray @ Shyamal @ chotka @ Maloy @ Ganesh is the master mind of Inter state car lifting racket and disposed the lifted stolen vehicles in Assam & Nagaland area under the leadership of him, During his PC period recovered and seized some quantity of suspected drug which was used at the time of lifting the hired about 10/12 medium vehicles like Scorpio, Ertiga, Maruti Swift Desire, Bolero, Tata Sumo etc.
