### 4. Important detections made by West Bengal Police:-

**i) Bidhannagar cyber crime PS Case No : 105/24 Dated 13/05/2024 US 419/420/406/120B IPC.** One Shraddha Jain W/O-Priyank Jain of 72 Bangur Avenue, Block D, 2nd Floor, Kolkata-55 came to Ps and submitted a typed complaint to the effect that she received a whats app message on her mobile regarding Google Review Tasks and later she joined a Telegram Group wherein she invested an amount of rupees 64.04 Lakhs/- as per the instructions received in the group under promise of getting the same with more profit and when she tried to withdraw the amount he was asked to pay more. Then she realized that he has been cheated and the entire process is a scam. Over this complaint instant cases has been registered.

**ii) Siliguri cyber crime PS Case No : 47/24 Dated 25/04/2024 US 419/420/120B IPC.** The instant case has been registered over the written complaint of Sri Rajesh Jaiswal, S/o Late Bhagawan Prasad Jaiswal, resident of Modak Complex, B.M. Sarani, Mahananda para, PO – Siliguri to the effect that he invested through online site name m.vikingglobalco.in from dated 15/03/2024 to 10/04/2024 to the tune of Rs.47.5 lacs for higher return as per instructions of Mr. Alok Thakur, Assistant of Mr. Sarvesh Srivastav admin of m.vikingglobalco.in in different bank account and they offered 300% as incentive upon his total investment. as per the instructions of Mr. Alok Thakur, he transferred through RTGS and IMPS, Rs. 42 lacs from his Bank of Baroda and Rs. 5.5 lacs from Kotak Mahindra Bank . Later

on when he tried to withdrawn money from the investment, he is unable to login the site to withdrawn from the investment. On that basis finally he realised that he was cheated by unknown fraudster.
