- a) **Reference:- Kotwali (Jalpaiguri) PS case No. 119/2017 dated 19.02.2017 u/s 370(5)/420/471/468/120B/34 IPC, 75/80/81 II (Care and protection of Children) Act, 2015.**

On 18.02.2017 a joint raid was held by the officers and force of POWC & SOG Cell, CID, WB under Kotwali PS area against trafficking of new born babies and they arrested 02 persons namely (i) Chandana Chakraborty (55) w/o Jiban Chakraborty of Keranitola, PS Kotwali, Jalpaiguri (ii) Sonali Mondal (30) d/o Jiban Mondal of Debinagarpara, left side of Durga Barimore, PS Maynaguri, Jalpaiguri. 17 babies were detected and 14 babies were shifted by CWC on the direction of the Director of child Health.

- b) **Reference :- Ghola PS case No. 83/2017 dated 15.02.2017 u/s 379/413/414/34 IPC r/w section 7(i)(a)(ii) EC Act.**

On 15.02.2017 officer and force of Railway & Highway crime cell, CID, WB held raid at Ghola PS area and arrested 03 persons namely (i) Krishna Kanta Sen (65) s/o Lt. Jagabandhu Sen of village Talbanda, PO Jugberia, PS New Barrackpur, North 24 parganas (ii) Paritosh Biswas (42) s/o Lt. Kedar Biswas of village Baikunthadeb Road, PO + PS Madhyamgram, North 24 parganas (iii) Prakash Chatterjee (40) s/o Badal Chatterjee of village Ghola C Block, PO Sodepur, PS Ghola, district North 24 parganas and seized 118 Gas Cylinder (Indane & HP gas) from the possession of the arrested persons. These gas cylinder were used for illegal business.

c) Reference :- Balurghat PS case No. 75/17 dated 17.02.17 u/s 21C/25/29 of NDPS Act.

On 17.02.17 officer and force of Dakshin Dinajpur DD, CID, WB held raid at Balurghat PS area and arrested 02 persons namely (i) Snehanshu Ghosh @ Laltu s/o Lt. Himangshu Ghosh of Dipalinagar (ii) Ajit Ghosh s/o Lt. Ramgopal Ghosh of Narayanpur, Balurghat and also seized 16800 bottles of phensidyl (worth Rs. 31,08,800/-) from the house of Nantu Ghosh of Dipalinagar, Balurghat.

d) Reference:- Raidighi PS case No. 41/17 dated 10.02.2017 u/s 370/120B IPC & 3/4/5/6/7/9 ITPA.

On 10.02.2017 officer and force, CID, WB held raid at Hotel Mahamaya, Raidighi, South 24 Parganas. The hotel owner Krittibas Kapat with the help of one Dilip Chatterjee and Rathin Swar (manager & staff of the hotel) used to procure few girls for commercial sexual exploitation at the same hotel. The officers and forces arrested accused persons namely Krittibas Kapat and 05 others. They also rescued 06 victim girls in c/w this case.

e) Reference:- Bhaktinagar PS case No. 132/17 dated 8.2.17 u/s 272/465/468/420/120B IPC.

On 8.2.17 officer and force of SS (North) office, Siliguri, CID, WB held raid at the factory of one Om Prakash Chowrasia of South Ektiasal under PS Bhaktinagar. The accused Om Prakash Chowrasia was running a business of manufacturing and selling spurious gutka in the brand name Tamana without any valid license for such business. The officers and forces arrested 02 persons namely Praful Chand Thakur and Ajoy Singh and seized spurious Gutka – 1,44,000 pouch, 900 kgs of raw materials, blank 22 No. of pouch pack from their possession.

f) Reference:- Sonarpur PS case No. 2611/16 dated 7.12.16 u/s 366A/370/370A/372/373/120B / 34 IPC and r/w section 3/4/5/6/7/9 ITPA Act, 4/17 of POCSO Act.

On 10.2.17 officer and force of AHTU Cell CID, WB held raid at Thakurpukur PS area and arrested accused persons namely Rintu Mondal, Sarbani Mondal and Jaya Majhi they also rescued three (3) minor girls. It was found that Joy Mondal used the minor girls for commercial sexual exploitation. Over this a separate case was started at Thakurpukur PS

vide Thakurpukur PS case No. 52/2017 dated 9.2.17 u/s 366A/368/370/109 IPC & 3/4/5/6/7/9 ITPA Act.

- g) **Reference :- Bandel GRPS case No. 9/2017 dated 22.2.17 u/s 51 of Wild life protection Act, r/w section 120B IPC.**

On 22.2.17 Officer & force of SOG cell CID, WB held raid at Bandel Railway Station area and arrested two (2) accused persons namely Tutia & Rajen, both of Gandhi Nagar, PS Jagdishpur, Dist. Amithi, Uttar Pradesh. The accused persons trafficked live Indian soft shell turtles of different shape and size from Uttar Pradesh to different place of West Bengal. The officers of CID, WB seized 174 pieces live Indian soft shell Turtles from the possession of the accused persons.

- h) **Reference:- Dankuni PS case No. 86/2017 dated 22.2.17 u/s 21(C) /25/29 NDPS Act.**

On 22.2.2017 a raid was conducted by the officer and force of Narcotic cell, CID, WB and arrested accused namely Shiv Kumar Sukla, Md. Nasim and Ashok Shil and also seized two vehicles having Reg. No. WB- 23D-1628, WB-23C-5192 along with 32100 bottles of phensedyl from their possession.

- i) **Reference:- Kotwali (Nadia) PS case No. 321/16 dated 5.5.2016 u/s 419/420/406/465/467/468/469/471/472/474/475/120B/34 IPC.**

The case in brief is that one Shyamal Dutta who disclosed himself as CEO & President of Bio Chemic Education Grant Commission Service being a fake notification. He used to run the office and fake medical court at Bakshi Lane, Bow Bazar, PS Kotwali, Nadia by using counterfeit seals of Govt. Of India, having national emblem, mark sheets, fake educational degree medical certificates in lieu of money. He was also running a court beside his office purportedly to be fake for the purpose of cheating to the common people in the society. The business of the accused indicates malafide intention to dupe people at large by issuing fake educational certificates in lieu of money. Six accused persons were arrested in c/w this case. On 21.2.17, officers of Anti Cheating and fraud cell, CID, WB has frozen Bijoya bank A/C No. 606801011000067 of the accused Rishi Raj Meena where cheated amount of Rs. 5,56,000/- was deposited

- j) **Reference :- Kaliachak PS case No. 155/17 dated 27.2.17 u/s 21 NDPS Act & 25/27 Arms Act.**

On 27.2.17 officer and force of Malda DD, CID, WB held raid at Kaliachak PS area and arrested one accused person namely Ahed Molla and seized 22 grams of Brown sugar, one piece 9mm improvised pistol with 6rds ammunition from his possession.

k) Reference:- Titagarh PS case No. 57/17 dated 27.1.2017 u/s 395 IPC & 25/27 Arms Act.

One Bithika Dutta w/o Bidyut Dutta of Kalyan gram, PO- Bengal Enamel, PS Titagarh lodged a written complaint to the effect that on 27.1.2017 at about 02.00 hrs 6/7 unknown miscreants entered into the complainant's house and committed dacoity in respect of Rs. 4,5 lacs and 10 bhori gold ornament. During investigation the IO of the case arrested the following accused persons.

- (3) Umar Ali Sardar (41) s/o Muslim Ali Sardar of Bhekutia, PO. Kapilshwarpur, PS Swarupnagar, North 24 parganas.

l) Reference:- Khardah PS case No. 158/17 dated 19.2.17 u/s 302/201/120B IPC.

One Jui Bhattacharjee w/o Jayanta Bhattacharjee of Kulinpara, gabtala, PO BD Sopan, PS Khardah, North 24 Parganas to the effect that on 17.2.17 at about 21.00 hrs the complainant's husband Jayanta Bhattacharjee a astrologer by profession, went out of his house to meet his client at Sodepur and since then he was missing. Later the dead body of Jayanta Bhattacharjee was found in a pond at Kalyannagar near Sishu Uddyan under PS Khardah. Over this incident Jui Bhattacharjee submitted a complaint suspecting one Mita Acharya, assistant of Jayanta Bhattacharjee and her husband Samar Acharya behind the murder of her husband.
