BIDHANNAGAR CYBER CRIME PS CASE NO 89/22, Dated 04.06.2022 U/S 419/420/468/120B of IPC and 20/20A of The Indian Telegraph Act 1885 on 03/06/2022 at about 16:15 hrs SI Moni Sankar Roy now attached to Cyber Crime Police Station under Bidhannagar Police Commissionerate received a credible information from his reliable source that few persons are running clandestine business of cheating in abroad and in India from an illegal call centre under the banner of a company styled as "Joinus Techsoft Consultancy Services Pvt. Ltd." at fourth floor, Meridian Building, GP Block Sector-V, Salt Lake City Kol-91 under Bidhannagar Electronic Complex Police Station. Mohammed Sakil and Jawed Hossain is the owner of this said company. They along with their other associates duped the innocent people and cheated huge amount of money from foreigner as well as Indian people also and violating the guidelines of Department of Telecommunication, they operated this unholy business. They used to call mainly in U.K, USA and Australia introducing themselves as the representative of Amazone customer care, Microsoft etc in the name of giving Amazone customer support and solving their problems regarding internet speed etc. They were running this illegal business engaging the unemployed youth.

Accordingly he diarised the matter vide Bidhannagar Cyber Crime PS GDE No. 50 dt. 03.06.22. After consulting with competent authority, he along with other officers and forces (including lady police personals) left PS to said place for verifying the said information with investigation kit box and taking other necessary things and documents.

During raid at the above mentioned international illegal call centre 09 (Nine) persons were arrested with seizure of good numbers of incriminating articles i.e hard disks from the remaining computers, print out of the leads along with the list of victims containing their credentials, he also seized the screen shot of IPs from their server room and admin's computer which are showing USA, U.K and Australia. It is pertinent to mention here that the IPs of both offices are same.

On the suo-moto written complaint of SI Moni Sankar Roy now attached to Cyber Crime Police Station under Bidhannagar Police Commissionerate this case was started & arrested two accused

They also cheated people in aboard by impersonating themselves as the representatives of different reputed companies in the name of creating delivery hub in their residence by alluring of huge monthly income.
