1). Ref : - Baranagar Ps Case No. 232/15 dated – 03.04.2015 U/s 413/414/120B IPC

On 03.04.2015 in between 08.35 hrs and 16.45 hrs on secret information held raid at Alambazar area under Ps Baranagar with the assistance of local officers and force at two places simultaneously under supervision of Spl. Supdt. of Police and Dy. S.P's E.B, W.B. During raid Inspector Sri Mrinal Das E.B, W.B seized huge quantities of Iron made materials and arrested two accused persons namely (i) Sudam Behera (19) S/o Gadadhar Behera of 67/1, Surya Sen Road, Ps- Baranagar, Kol- 35 and (ii) Jagannath Mahato (35) S/o Mahadev Mahato of Manipur, Ps- Sandeshkhali, North 24 Pgs. for running clandestine business in respect of above seized articles in collusion with other accused persons by stealing, storing and selling the same to the general customers. In this connection Inspector M. Das submitted suo-moto complaint to O/C Baranagar Ps for starting the above noted case.

2). Ref : - Baranagar Ps Case No. 233/15 dated- 03.04.2015 U/s 413/414/120B IPC

Simultaneously, SI Prabir Kr. Mondal of E.B, W.B seized 473 Bags Cement of different Companies, 21 bags of Sugar, 3 Bags of Maida, 3 TATA- 407 Vehicles, 90 empty Cement Bags and Weighing Balance with Weight measure and arrested 3 accused persons namely (i) Joynarayan Mukhiya (35) S/o Basudev Mukhiya of Shibnagar, Ps- Benipati, Dist- Madubani, Bihar, (ii) Ram Sevak Kamat (22) S/o Lt. Bacchulal Kamat of Gamaria, Ps + Dist- do and Bhola Mukhiya (28) S/o Jogin Mukhiya of Kawarnawatul, Ps- Bistir, Dist- Madhubani, Bihar for pilferaging, storing and selling such type of above noted articles keeping the same in the godown under pacca boundary wall with the connivance of other accused persons including owners / drivers of different good carrying vehicle. In this connection SI P. Mondal of EB, W.B submitted a suo-moto complaint to O/C Baranagar Ps for starting the above noted case.

(5) **Interesting detections by CID, West Bengal :-**

(1) Ref :- Bolpur Ps Case No. 158/15 dated- 01.04.2015 U/s 379/411/413/414 IPC and sec-25 of Antiquities and Art Treasures Act 1972.

On 01.04.2015 in pursuant of a source information SI Sandip Ganguly along with other officer and force of SOG CID, W.B held raid at the area near Prantick Railway station under Bolpur Ps and secured arrest of 2 (two) persons namely (1) Sk Babu (22) S/o Sk Kiyab of Vill- Kalyanpur, Ps- Saithia, Birbhum and (2) Abdul Hadi (30) S/o Sk Sirajuddullah of do dealing with antique articles and recovered and seized total 348 nos. of golden colour metal coins in where some urdu like letter engraved in each seemed to be an ancient antique from their exclusive possession. On the basis of written complaint of SI Sandip Ganguly the instant case was started. Subsequently the control of investigation has been taken up by CID, WB vide org no.467/CS dated 02.04.2015. SI Manotosh Raj of SOG CID, WB took up its investigation.

(2) Ref :-Gangnapur Ps Case No. 38/15 dated 14.03.2015 U/s 395/397/376 IPC Adding sec 212/216A IPC and Bongaon GRPS Case No. 33/15 dated 23.04.2015 U/ s 14 Foreigner's Act.

On 23.04.2015 afternoon a raid was held by a team of officers and men of DRBT CID, WB at Bongaon Railway Station area and arrested accused person, viz. Khaleder Rahaman Mintu @ Faruq (33) S/o Abdul Latif Sarder of Vill- Noapara, Madhyapara, Ps- Adhaynagar, Dist- Jessore, Bangladesh was arrested in c/w Gangnapur Ps Case No. 38/15 dtd- 14.04.15 U/s 395/397/376 IPC Add. Sec 212/216A IPC, from Platform No.-1 of the railway Station. During interrogation the accused person confessed that he had entered into Indian mainland clandestinely today through Indo-Bangladesh border. On being asked he could not produce any valid document permitting his entrance into Indian mainland and such he is liable for prosecution U/s 14 Foreigner's Act. On the basis of written complaint of Inspector D. Bhaumik of DRBT CID, WB the instant case was started vide Bongaon GRPS Case No. 33/15 dtd.23.04.15 U/s 14 Foreigner's Act. Subsequently the control of investigation has been taken up by CID, WB vide org no.548/CS dated 24.04.2015. SI Joy Roy Chowdhury of DRBT CID, WB took up its investigation.
