





4. Important detections made by West Bengal Police:-

1) New Town PS Case No. 135/24 dt. 22.05.24 U/S 364/302/201/120B IPC has been initiated on the written complaint of SI. Sovendu Kr. Goswami of Baranagar PS, Barrackpore Police Commissionerate, against 1) Amanullah Sayed (BD PP No. EE0182198) 2) Celesty Rahman (BD PP No. A13202631) 3) Md. Mustafizur Rahman (BD PP No. A14466597) 4) Faisal Ali Shazi (BD. PP No. A14466596) 5) Zahed @ Jubair 6) Siam Hossain 7) Akhterruzzaman @ Sahin and others. Fact of the case in brief is that the complainant started an enquiry of missing of one Md. Anwarul Azim Anar (56 yrs), Hon'ble Member of Bangladesh Jatiya Sansad who went missing from the area of Baranagar PS as per information of one Gopal Biswas, vide M.P. case No. 65 of 24 dt. 18.05.24. During enquiry the complainant found out that the missing person entered at BU-56, Sanjeeva Garden under New Town PS on 13.05.24 at around 15:10 hrs. It was also revealed that the said flat had been rented to Md. Amanullah Sayed, Celesty Rahman and Md. Akhterruzzaman @ Sahin all are Bangladeshi national. As per information, it was presumed that Mustafizur who stayed with one Faisal went to Sanjeeva Garden on 10.05.24. On 13.05.24 Faisal went to Axis Mall with one driver Siddartha Kundu but didn't return to the P.O. The location of the missing person was latched at Axis Mall around 16:15 hrs but he personally had not gone there. The driver picked on Zehad @ Jubair from the P.O. on 14.05.24 around 14:00 hrs with one blue trolley bag. It was also revealed that one Siam Hossain brought Zehad on 06.05.24 and left him at a flat near Chinar Park which is a flat of Akhterruzzaman. Celesty Rahman left the P.O on 14.05.24 with Amanullah at 10:00 hrs and were carrying big trolley bags. Having much weight. Faizal and Mustafizur, Amanullah and Celesty left india on 19.05.24 and 14.05.24 Akhterruzzaman also left India and on 20.05.24 he left Bangladesh and reached Nepal it was also informed by Bangladesh Police that Amanullah and Celesta have been detained by them and they have confessed that they have murdered the MP. Md. Anwarul Azim Anar on 13.05.24. for monitary dispute and the body of the victim has been cut into pieces and has been disposed off at different places. Their statement corroborates the C.C.T.V footage found at the P.O where it is seen that the victim did enter in Sanjeeva Garden but had not come out. Hence it is felt that the accused persons had well planned the murder of the victim and subsequently had conspired to disposed off the body to conceal the evidences.
