



**i) Chanchal PS- Case No.1678/23, dtd.26.12.2023 U/S-395/397 IPC R/W 20(1)(a)(B)/27/35 of Arms Act.** The case was Started on the written complaint of Muktar Ali S/O-Late Abdus Subhan of Nazrulpally Post & PS-Chanchal, Dist-Malda against five unknown Miscreants to the effect that on 25/12/23 at about 18:45 hrs the 05 unknown Miscreants all are being mask on their face and having fire arms entered into the Chanchal Dhaka Jewellery shop and committed dacoity in the said jewellery shop. They looted golden jewellery approx 1) 22 k Gold(8 Kg 178 Gram 427 Miligram), 2) 18K gold(91 Gram 808 Miligram) 3) Old Gold 22Gram 820 Miligram 4) Hira-10 Carat 16 Cent and 5) Silver-10 KG 486 Gram 40 Miligram, cash amounted approx 1 lakh 60 Thousands Total amount approx 4 crore 35 lakh. The said miscreants also assaulted two employees of the said jewellery shop and after dacoity the shop, they also fired in the air. Five accused had been arrested 1. Sk Gultan, s/o-Late Sk Badiruddinof Bijhara, P.O- Kurumhat, P.S- Baliabelon, Dist- Katihar, Bihar, State: Bihar, 5. Abhay Kumar Suman, s/o-Birju Ravi Das, Hakur Ganqti Dist- Gadda Jharkhand, State: Jharkhand.

**ii) Goalpokher PS Case No. 111/2024 Dated: 29.02.2024, U/S- 489(B)/489(C)/120B IPC** The case was started, on the basis of Police complaint of SI Md Arif Hossain of Panjipara OP under Goalpokher PS against the accused person namely 1) Sehena Khatun (30) W/O- Sk Mahiruddin of vill-Kadamtola Durga Mandir , Medical More PS - Matigara Dist-Darjeeling and others to the effect that on 29.02.2024 at 11:25 Hrs, SI Dibyendu Das, In- Charge Panjipara OP under Goalpokher PS, Islampur PD received a telephonic information from SI Abhijit Bhowmick of STF West Bengal, that one woman was carrying fake Indian currency notes in a Blue colour vanity bag with ill motive along with one girl named Payel from Domohona under Karandighi PS towards Siliguri side boarding by a NBSTC Bus having bus displaying no - WB 63A/8758 and the fact was noted in GDE and he also informed the matter to IC Goalpokher PS and after getting permission directed SI Md Arif Hossain as well as the RT officer ASI Safi Kamal and his team with other forces reaching at Panjipara Bus Stop on the NH 27 in the Siliguri Flank and started Naka checking and later also ASI Safi Kamal and his team joined and at 11:45 hrs on seeing the aforesaid Reg. number of a NBSTC Bus gave signal to the bus driver and managed to stop the said bus and started searching and found a suspect woman having a blue colour vanity bag along with a minor girl as per our credential information sitting in the back side of the Bus and then on being interrogation the said woman disclosed her identity as noted above and also identified the said girl as her daughter namely Payel Khatun (11) D/O Sk. Mahiruddin of vill-Kadamtola Durga mandir ,Medical more PS- Matigara Dist-Darjeeling but could not produce any relevant documents in support of the said girl. Thereafter SI Md Arif Hossain got off them from the bus and called in the disinterested witnesses from the Bus having Reg No-WB 63A/8758 and searched by Lady constable the Blue colour vanity bag in possession of the said Sehena Khatun and recovered total 198 pieces in denomination of RS/-500 of seemed to be Fake Indian Currency Notes (Total amount RS/-99,000/- Ninety nine thousands) of four different serial numbers and the notes contained in two separate bundle tied with two separate rubber band, genuine Indian currency of RS.11590/- and one mobile phone and then seized the total 198 pieces of seemed to be fake Indian Currency Notes in two separate bundles tied with two rubber band (one bundle 100 pieces and another bundle 98 pieces) and arrested two 1. Sehena Khatun s/o-Sekh Mahijuddin of vill-kalamjote,PO-PO-Sushruta naga Matigara Dist-Darjeeling , PS: Goalpukur, District: Islampur Police District, State: West Bengal, 2. Badruddin SK s/o-Shaheb SK of PS:

Goalpukur, District: Islampur Police District, State: West Bengal.

**iii) Goalpokher PS Case No. 101/2024 Dated: 24.02.2024, U/S-395/397 IPC r/w Sec 25(1A)(a)/27/35 Arms Act.** On the written complain of night Duty of Security Guard namely Kafil Ahmed (45) S/O-Lt Sabbir Alam of Vill- Panjipara school Chowk Ps –Goalpokhar Dist – U/Dnj against the 05 unknown miscreants to the effect that on 23/02/24 at around 03:30 minutes, he suddenly heard a sound towards the Salina Complex market, ran towards the market and saw that 5 miscreants were standing in front of the market and they were trying to break the lock of the grill gate of the market. When he went to stop them, as soon as the miscreants saw him, they dragged him, grabbed his face, and tried to kill him by stabbing, punching and kicking indiscriminately. At that time the miscreants broke the lock of the grill of the market and entered and tied his face and hands and feet with a black cloth and left him on the stairs of the said market. After that they broke the lock of the grill gate with an iron saber and other tools and also broke the Sarkar jewellery shop's shutter entered the shop and stole all the gold and silver ornaments from the shop in a bag and ran away. Later he untied his hands and feet and called out to the people and at that time Panjipara he informed the civic who performing duty at Panjipara Bazar. Then & there Police party started searching around the Panjipara area. After reaching at Satvita village field road five persons are walking with bicycle. When they saw the police party coming towards them, they started to ran away from the spot. After a hot chase police party detain two persons, 1. Prabhat Singh (56) S/O Lt. Kallu Singh of Vill- Bhojpur, PO-Mohammadganj PS- Kadar Chowk Dist, Baduan UP, 2. Dinesh Kumar (48) S/O- Hanuman Singh of vill Bhojpur PO- Mohammadganj PS- Kadar Cchowk Dist- Badaun UP, On interrogation they gives in coherent statement about their address .Then they were searched for inconsistencies in their statements. During search gold jewellery are recovered from their possession and also recovered a improvised fire arms and 08 round live ammunitions. After that all gold ornaments and fire arms with live ammunitions are seized.
