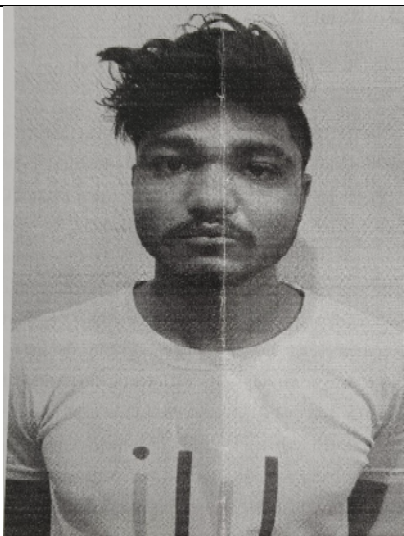

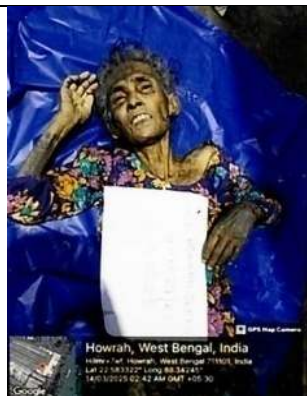

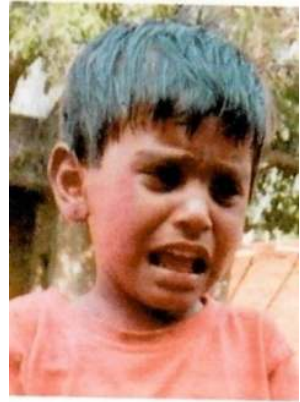

4. Important detections made by West Bengal Police:-

1. Chandannagar Cyber Crime PS Case No : 10/25 Dated 19/05/2025 U/S 319(2)/318(4)/61(2) BNS. On 19.05.25, SI Bikramjit Sarkar of Serampore PS, Chandannagar PC lodged a complaint to the effect that on 18.05.2025 at 21:05 hrs. while he was performing evening RT duty at Serampore PS area he received a credible source information and as per permission of IC, Serampore PS and with the assistance of the team of Cyber Crime PS, CPC, he along with his team went to work out the information (vide Serampore PS, CPC GDE No- 1367 Dated 18.05.2025) who were engaged with some sort of online monetary transaction through which they misappropriated money from innocent people fraudulently in near past and their present whereabouts is at Shib ghat, in front of India Jute Mill, William Carrey Road, Serampore, Hooghly. At about 21:15 hrs, he along with his team proceeded for Shib ghat, in front of India Jute Mill, William Carrey Road, Serampore, Hooghly to work out the information. He reached his target place and searched for some disinterested witnesses but due to the night hours no one turned up to accompany them in the raid. Thereafter as per the tip, Police party rushed to the proper

place after keeping the Police vehicle in some distance. At the said place they found that the above noted persons were sitting in a car bearing reg. no. WB02AV0477 and detained them to verify the information police team have. On interrogation they made different statements in different times to mislead the police party at the initial stage. Hence, police team detain them and brought at Serampore PS. After prolonged interrogation they finally disclosed their identity as 1) M.S Ramesh (39) S/O Lt. Soundarajan of 1/67B Kottal Thottam, Valipathi, Rengampatti, Krishnagiri, PS-Mathur, Tamil Nadu 635306, 2) Sarifuzzaman Gazi (54) S/O Lt. Sirajul Haque Gazi of Basantapur, PS. Haringhata, Dis. Nadia , 3) Sumit Sharma (19 yrs) S/O Lt. Ramesh Sharma of 67/1, Sk. Nagar, PS-Serampore, Hooghly, 4) Vinoth Gangadharan M (36) S/O Lt. Manickam of 3552, LIG 1 TNHB Avadi, PS- Tiruvallur, Tamil Nadu- 600054, 5)) Pattu John Samuel S (60) S/O Selvaraj of 244B, Nehru Nagar West Street, Christiya Nagar, Ariyappam Palyam, Erode, PS-Sathyamalagam, Tamil Nadu- 638402, 6) Noushad EK (46yrs) S/O Muhammed of 482, Elikkal House, Kalchira, Kavalamukatta, PO. Amarambalam, Malappuram, PS-Pukottumpadm Kerala. 679332 and 7) Md. Azhar (41) S/O Md. Usman of 57, North Range, Circus Avanie, PS- Beniapukur Kol. 700017 and admitted that they are engaged with some sort of online monetary fraud and supply the banking credential to others. Recorded their statement u/s-180 BNSS and seized huge numbers of banking credentials under proper seizure list. After that he arrested them by issuing Memo of arrest, Inspection Memos and issued intimation of ground of arrest after stating them ground of arrest in between 04:35 hrs and 05:30 hrs as at this preliminary stage their involvements are established and if they are not arrested, they may escape and may tamper evidences. Furthermore, on verifying National Cyber Crime Reporting Portal (NCRP) with the help of Cyber Expert team of Cyber Crime PS, CPC and found that 12 Bank Accounts are engaged with 99 numbers of NCRP Complaint having acknowledgement numbers in NCRP portal. Over the basis of the complaint of SI Bikramjit Sarkar Chandannagar Cyber Crime PS Case No- 10/2025 dated 19.05.25 u/s 319(2)/318(4)/61(2) BNS started and as per endorsement PSI Sudipta Kar took up its investigation.
