4. Important detections made by West Bengal Police:-

a) Ref. CID CyberCrime PS Case No.07//22,Dated 23.08.2022, U/S-419/420/467/468/120B34IPC.& Control Order No, Org. No. 681/CI Dated 23.08.2022

On 22.07.2022. at about 13.35 hrs.,SI Sujan Ghosh of Salt Lake DD, CID,WB receied a credible source information that some persons are running a clandestine buisess of fraud call centre by calling at abroad under the banner of a company styled as "Panjio Sparta Service LLP"Situatred at Astra Tower, 6th Floor of South Block, Astra Tower, Action Area-IIC, New Town, Kolkata Under Eco Park PS Bidhan Nagar Police Commissionerate . One Rony Paul and Chandan Bajajare the owner of the fake call centre and the directorship are in the name of Mala Moitra and Sandip Kumar Moitra who with the help of others ,are operating this illegal call centre and cheated common people through India in the name of Instalation of Airtel Tower and issued of Magma Life Insurance, Future Generally Life Insurance and Others.

The complainant along with officer and force reached at the aforesaid premises and found that some female and male person are sitting in front of a long desk talking suspiciously through landline phone. The complainant arrested the Six accused persons and seized hard Disk, Telephone and documents. During interrogation the accused person confessed their guilt as to the commission of offence brought against them and stated that they used to run this fake call centre to dupe the peoples. They also stated that they have another premises at room no 707 of the south block, Astra Tower, Action Area –IIC, NwTown, Klkata which was also used for same purpose. It is also stated by the accused person that they also have fake call centre under the same owner at Bindhubasini Karket Complex Mangaldeep, Palki, Teghoria main Road under Baguiati PS f Bidhan Nagar Police Commissionerate.

b) Ref. Asansol GRPS (Howrah GRP) Case No.49/22 dt.15.12.2022 u/s-365/366A/366B/370 IPC & Foregners Act.

On 15.12.2022 whille performing joint drive against unusual elements at Asansol Station Platform with force, She noticed some suspected persons (06 Female & 02 Male) at second class waiting room of Asansol R/S During interrogation it was found that five Girls were minor & One Girl was Major and were from Bangladesh and the male Persons accompanying them disclosed their identity as Noor Rashid (31 Yrs.) and Abdulla(20 Yrs.). One of them was from Bangladesh and the other from Mayanmar,both of them induced & influenced the girls from Bangladesh and were trafficking them illegally to Delhi under the false hope of providing better future. They neither had Passport to enter India nor any other legal documents.
