



After that she along with DDI, Barasat DD CID, SI Malay Kumar Ghosh, ASI Ranjit Mandal, W/CT-16 Rana Roy of , Barasat DD, CID, WB left for Amdanga PS area to work out the said source information with our Govt. Vehicle No. WB 02AG 6166 and WB 24 AM 7946 vide GDE No.119 C.C. No. 98 /25 Dt. 21.11.25.They arrived at Amdanga PS Area at about 19.45 Hrs. met with a source, who was waiting for them and exchanged information. She along with officers and force held a raid near an online lottery shop (App-Play to Win, ID-BS11), Kachari More, Arkhali, beside NH12, PS- Amdanga, PIN- 743221 as shown by reliable sources. They found that some persons were conducting an online lottery through computers. Seeing the police van, they started to flee away but they managed to apprehend the above noted persons and recovered the articles noted above.
