

They used to cheat common people throughout India in the name of issuance of different insurance, Credit Cards, providing loan, etc. and also by giving false promises of high monthly income in lieu of installation of mobile towers. The instant case was registered on the written complaint of Shri Somnath Mukherjee S/o Late Sachindanada Mukherjee, CEO, Konnagar Sambaya Bank Limited , 66 , G.T Road (West) , P.O Konnagar, P.S Uttarpara, Dist .Hooghly .It was alleged in the complaint that Konnagar Sambaya Bank Limited has a current account in the Kolkata Main Branch of the West Bengal State Co- opertave Bank (WBSCB). On 24.03.2017 an e-mail from the official mail id of k Konnagar Sambaya Bank Limited was received by the Kolkata Main Branch of WBSCB at their mail id containing a scanned copy of the letter of Konnagar Sambaya Bank Limited with a request to transfer Rs. 60 Lakh from the current account of konnagar Sambaya Bank Limited to one account of ICICI Bank, Chandausi, U.P. which is in the name of Md. Gulzar. Accordingly the WBSCB transferred the amount. The Konnagar Sambaya Bank Limited had insufficient fund in its current account. Despite having insufficient balance, the transfer of fund was done leaving thereby a debit balance of Rs. 21,58,843.09 in the said accunt of the Konnagar Sambaya Banl Ltd.

The case was initially investigated by Chadannagar Police Commissionarate.Later,as per order of the Hon'ble High Court ,Calcutta the investigation of the case was taken up by the CID, WB.
