

On 06.03.2025 at 17:15 hrs. received a type and singed complaint from Palash Roy, District Inspector of Schools (Secondary Education), Purba Medinipur to the effect that the then Administrator of Khamarchak High School took a resolution vide order no. 17 dated 23.10.2009 to appoint Sri Ayan Kumar Das as Assistant Teacher in Work Education for Khamarchak High School without honorarium and also resolved that there will be no objection of the School Authority if the said appointment will be regularised in future. On the basis of the said resolution, the Administrator of the School issued appointment letter to Sri Ayan Kumar Das vide Ref No. KHS-23/10 Dated 23.10.2009 as honorary Assistant Teacher in Work Education subject. On the basis of the said appointment letter, Ayan Kumar Das joined on 12.11.2009 as honorary Assistant Teacher in Work Education to Khamarchak High School and the then Headmaster of the said School allowed him to work as honorary Assistant Teacher in Work Education subject w.e.f. 12.11.2009. Thereafter the then District Inspector of Schools (SE), Purba Medinipur accorded the approval of appointment w.e.f. 12.11.2009 in favour of Ayan Kumar Das as Assistant Teacher in Khamarchak High School vide Memo No. 1894-S Dated 31.12.2018. After this approval, Sri Ayan Kumar Das has been serving in the Institution as approved Assistant Teacher and getting salary regularly since February 2019. The Issue Register of this Office for the year 2018 (from 01.01.2018 to 31.12.2018) has been seized by the CID, West Bengal on 08.12.2023 in Tamluk PS Case No.1294/23 Dated 04.12.2023. There is no document found in the office in relation to appointment of Sri Ayan Kumar Das. All the aforesaid documents have been received from the Assistant Headmaster/TIC of Khamarchak High School on 19.02.2025 vide Ref. No. KHS-92/2025 Dated 19.02.2025. The appointment was made on 12.11.2009, but the prevailing recruitment rules do not permit this appointment. So the appointment of Sri Ayan Kumar Das is beyond the recruitment Rules. In this respect the Headmaster did not mention anything to the then Administrator against this appointment. So Sri Ayan Kumar Das, the then Administrator and the then Headmaster may be involved in these activities, even some other person/persons may have been involved and Sri Ayan Kumar Das has got wrongful gain from this appointment. There is no document found in this office regarding the approval of appointment of Sri Ayan Kumar Das, (the office issue register for year 2018 has been seized by the CID, West Bengal). Either office procedure was not followed or if followed, then documents have been dislocated and unknown person/persons may have been involved in missing of these documents. It is also not clear how the then District Inspector of Schools (SE), Purba Medinipur issued the approval of appointment.
