Special Notice-


Judgment of the Hon'ble Supreme Court given in the matter of Shreya Singhal Vs Union of India on 24.03.2015 whereby Section 66A of the Information Technology Act 2000 was struck down, becoming null and void with effect from the date of order i.e 24.03.2015 and hence no action could be taken under this section. In this connection, all States & UTs were advised vide Meity DO letter no. 4(13)/2012- CLFE/Vol-II dated 11.01.2019 and MHA letter No. 21021/46/2016/IS-II-M dated 14.01.2019 and 01.04.2019, to sensitise the Police department/ local Police authorities in your State/UT for strict compliance of the Hon'ble Supreme Court order dated 24.03.2015 and withdrawal of all such cases, if any, which were booked under the section 66A of the IT Act 2000 in your State/ UT.

It has been brought to notice through an application in Hon'ble Supreme Court that FIRs are still being lodged by some police authorities under the struck down provision of Section 66A of IT Act 2000. Hon'ble Supreme Court has taken a very serious view in the matter.

It is therefore, requested to direct all the police stations not to register cases under the repealed Section 66A of the information Technology Act,2000 and sensitise the law enforcement agencies for the compliance of the order issued by the Hon'ble Supreme Court on 24.03.2015. If any case has been booked in your State under section 66A of the IT Act, 2000, it should immediately be withdrawn.



PART- III – Cases with Peculiar Modus Operandi –

(i) Ref. CID, Cyber Crime PS. Case No. 05/21 dated 02.07.2021 u/s 417/419/420/465/468/469/ IPC r/w section 66C IT Act, 2000.

The victim complainant Ajim Hossain Piyada received a telephonic call where the caller convinced him as an officer of Bajaj Finance and cheated him with Rs. 32880/-. Again on 08.07.21, he further received a telephonic call from different phone nos where the callers introduced themselves as officers of Aditya Birla Finance. The complainant sent some documents to them as per their direction through WhatsApp. They told him that a loan of Rs. 3, 45,000/- has already been sanctioned in his name but for that he had to buy an insurance policy of Rs. 5,800/-. They directed him to send Rs. 5,800/- to their Bank A/C. The complainant sent the said amount to that account. Lateron he realized that the miscreants cheated him in both the occasions. During investigation, it was found that the accused persons had cheated several other victims by pretending themselves as either bank officers or insurance officers and on ground of setting up JIO tower. The accused persons had used a Fake call centre to dupe innocent persons.

(ii) Bidhannagar (North) PS Case No. 140/2020 dated: 09.09.2020 u/s 420/468/471/474/120 B IPC, adding section 467 IPC.

The instant case was started over the complaint of Sri Nirmal Kumar Mosha, Assistant Director, (PMLA), Directorate of Enforcement, Salt lake, Kolkata, who is also the petitioner of the instant C.R.R. The allegations in brief is that investigation of case of Rose Valley scam is being done by the zonal offices of Enforcement Directorate out of which two ECIR s are being done by Kolkata Zonal Office at CGO Complex, Salt Lake, Kolkata. The amount involved in the case is Rs 17500/- Crores (approx.). During investigation Sh. Gautam Kundu and other persons including Sh. Sudipto Ray Chowdhury were arrested. During their investigation it was noticed by ED that some unscrupulous efforts were made with ulterior

motive of cheating the authorities and with mala fide intent to mislead, obstruct and misdirect the course of investigation by way of writing under a stolen identity to different authorities by forging /tampering/falsifying/superimposing the documents. There is also possibility of extortion by showing such false documents by the persons behind it. During investigation under PMLA ED found that prima facie most of the documents were forged by superimposing signature and official stamps. Statements of connected persons under PMLA also show that the documents are forged

After notification of the Insolvency and Bankruptcy Code, 2016, Insolvency Professional play a key role in managing rescue and liquidation process envisaged under this Code' in the rescue process, the insolvency professional is the resolution professional and gathers financial information about the debtor, verifies the claims of the creditors, constitutes a committee of creditors on the basis of credit exposure, safeguards the estate, runs the business of the debtor and helps in reaching and administering a consensual rescue plan. In a liquidation proceeding, the insolvency professional is liquidator and sells the assets of the insolvent company and uses the proceeds to pay off all its creditors. section 233 of the Insolvency and Bankruptcy Code, 2016 provides protection to an insolvency Professional from the legal suit or other legal proceedings for anything done or intended to be done in good faith under this Code or rules or regulations made there under. section 19 of the Code provides that the personnel of the corporate debtor, its promoters or any other person associated with the management of the corporate debtor shall extend all assistance and co-operation to the interim resolution professional as may be required by him in managing the affairs of the corporate debtor. The insolvency professionals, being appointed by Adjudicating Authority as interim resolution professional may face hindrances taking over the, management of the corporate debtor. It is to be borne in mind that after notification of the Code, and in terms of section 236(2) of the said Code, there is bar on trial of offences against an insolvency professional except on a complaint filed by the Insolvency and Bankruptcy Board of India or the Central Government or any person authorized by the Central Government in this behalf.

Apart from this, Section 238 of this Code shall have effect, notwithstanding anything inconsistent therewith contained in any other law for the time being in force or any instrument having effect by virtue of any such law. In view of the statutory mandate of the Code, all SPs/ Cps/ Range DIGPs/ Zonal IGP are requested to sensitize the field functionaries to strictly comply with the above provisions of the Code. While discharging the duty of the insolvency professional, the concerned Police Station shall make proper and effective assistance to the resolution professional in valuation of the company and shall initiate suitable action against the corporate debtor if needed presuming that the corporate debtor is not obeying the order of the Court.
