iii) Galsi PS Case No 380/23 Dt 24.06.23 U/S- 379/411/414/120B IPC. And 15(2)/15(4)/16 of The Petroleum and Minerals Pipeline Act 1962 and subsequent amendment, 2011 and section 3/4 PDPP Act and 3/4 Explosive Substance Act.

The fact of the case in brief is that in the last couple of months IOCL noticed pressure drop to Haldia-Bolpur section of PHBPL pipeline. They were searching to detect the reason for pressure drops. Finally on 24.06.2023 afternoon pilferage was detected in the midst of the open field at Belgram Mouza under Galsi PS by the inspection team of IOCL. There is a Chemical Factory (Swami Devananda Chemicals) adjacent to approx 300 mtrs from the IOCL pipeline. After thorough searching a trench mark from the boundary wall of the said factory towards the IOCL pipeline was noticed. Accordingly the inspection team of IOCL started excavation with JCB immediately following the trench mark. After excavation one illegal valve tapping from the mainline of IOCL has been detected which directly goes into the chemical factory. After then with the help of Galsi PS the inspection team of IOCL entered into the premises of the said Chemical factory & a valve fitting with hose was found inside of a shed. Total 150 nos empty 40 Ltrs Jar were recovered among them 06 nos jar were filled with crude oil of Indian oil. The owner of the factory along with others laid a pipeline from IOCL crude oil pipeline to his factory premises and had stolen the crude oil.

iv) KLC(KOLKATA POLICE) PS CASE NO 03/23 DT 06.01.23 u/S 419/420/465/468/471/120B IPC r/w 66/66C/66D/84B IT Act 2000, Control order no: 202/CS dt 25.02.23

The case in brief is that on 06.01.2023 SI Sandeep Oraon of Kolkata Leather Complex Police Station received a credible source information from his source a fake and fraudulent call centre is being run at Villa No 2, Ideal Villa situated at Village Koachpukur, PS- Kolkata Leather Complex, 24 Parganas (South) where voice over internet protocol calls are being made to the residents of United Kingdoms. The miscreants falsely represented them as employees of reputed company Amazon and promise them to provide various online products and gradually cheated them convincing them to pay money in their desired accounts. On getting approval the SI Sandeep Oraon of Kolkata Leather Complex Police Station took approval from the competent authority and held raid at Villa No 2, Ideal Villa situated at Village Koachpukur, PS- Kolkata Leather Complex, 24 Parganas (South) with police team and found that a fake and fraudulent call centre was running there with laptops and other gadgets. The SI arrested the petitioners of the CRMs from the P.O. and seized Laptop, Mobile phone, Car from the P.O. and submitted the written complaint before the Officer-in -Charge, Kolkata Leather Complex Police Station for lodging FIR. Accordingly, Kolkata LeatherComplex Police Station case no. 03 dated 06.01.2023 U/S 66/66C/66D/84B IT Act r/w 419/420/465/467/468/471/120B IPC.

v) Bidhannagar Cyber Crime (Bidhannagar Police Commissionerate) PS case no. 82/2022 dt 27.5.22 u/s 419/420/468/120B IPC and 20/20A IT Act 1885

The fact of the case on 26/05/2022 at about 15.15 hrs a credible information was received by BDN Cyber Crime PS that few persons are running clandestine of call centre business by calling in abroad under the banner of a company styled as 'ORAGMA VENTURES PRIVATE LIMITED' situated at 10th Floor, Unit-1003, Godrej Genesis Building,

Sector-V, Salt Lake, Kol-91 under Bidhannagar Electronic Complex Police Station. Mohammed Khurshid Alam and Raheel Mohammed Syed are the owners of this company. They along with their associates duped the innocent people and cheated huge amount of money from them violating guidelines of Department of Telecommunication. They used to call mainly in U.K, USA and France introducing themselves the representative of different Companies like telecom support, domain related support, tech support, website selling and solving their problems regarding internet speed. They were running this illegal business engaging the unemployed youth.

vi) Bidhannagar Cyber Crime PS Case No 89/22, Dated 07.06.2022 U/S-419/420/468/120B of IPC and 20/20A of The Indian Telegraph Act 1885.

The accused persons are running a clandestine business of fraud call centre by calling in abroad under the banner of a company styled as "JoinusTechsoft Consultancy Services Pvt. Ltd" situated at forth Floor, Meridian Building, GP Block Sector-V, Salt Lake City, Kol-91 is situated under Bidhannagar Electronic Complex Police Station. Mohammed Sakil and Jawed Hossain is the owners of the company. They along with their associates duped innocent people and cheat huge amounts of money from them violating the guidelines of the Department of Telecommunication. They used to call mainly in the U.K, USA and Australia introducing themselves the representative of Amazon Customer Care, Microsoft etc in the name of Amazon Customer support and solving their problems regarding internet speed etc.

vii) Kashipur PS Case No. 277/23 dated: 16.06.23 u/s 302/34 IPC and 25/27 Arms Act.

The fact is that on 16.06.23 one Rithik Naskar S/O Chunilal Naskar of vill- Hatgacha, PS-KLC, South 24 Parganas submitted a written complaint at Kashipur PS that on 15.06.23 the complainant and his father-in-law Raju Naskar was going to Bhangore-II block for nomination purpose in c/w Panchayet Election 2023. At about 14.00 hrs they reached near Panapukur more. Suddenly some miscreants of ISF supporters attacked the victim by iron rod, bamboo, sword, bombs etc in conspiracy of MLA Nousad Siddique. The ISF hooligans assaulted badly the victim Raju Naskar. The miscreants ensure his death by firing on him. The complainant fled away to save himself. Over this incident above noted case was recorded. Later the case has been assumed control for investigation by CID, W.B vide Crime West Bengal Org No 594(A)/CS dtd- 22/06/23 detailing myself as investigating officer.

viii) Kashipur PS Case No. 331/23 dtd.12/07/2023 U/S- U/S - 147/148/149/186/188/189/353/332/333/326/307/427 IPC & 25/27 Arms Act, 1959 & 3/4 Explosive Substances Act, 1908 & 3/4 Prevention of Damage to Public Property Act, 1984 & 9 West Bengal Maintenance of Public Order Act, 1972.

The fact of the case is brief that on 12.07.23 SI Pradip Paul of O/C Kashipur PS lodged a suo-motto complaint against Raju Molla (30 Yrs) S/o- Hamid Molla of Chinipukur, P.O-Shonepur, PS-Kashipur, South 24 Parganas and 12 others FIR named and 3000/4000 ISF supporters and leaders. On 11.7.2023 was scheduled for counting of votes in c/w Panchayet General Election-2023 and strong room was previously set up at Kathalia High School (HS). After hearing the result of winning by the candidates of AITMC party, ISF supporters who were present there started to give slogan against the Police. Suddenly the mob became violent and started pelting stones and brick bats aiming the Police personnel who were performing duties at the respective drop gates on both sides of the venue on the metal road. The mob started to hurl bombs aiming to the Police parties. They were

cautioned repeatedly using of loud hauler. But the riotous mob became more violent and continued hurling of bombs started firing aiming towards the Police party as a result on duty Police party. Considering the situation Akhter Ali, DySP, Crime, Baruipur PD again cautioned that unruly mob to disperse and to refrain from pelting stone/ bombs and firing through loud hailer, CI Bhangore and officer of PS also did same. O/C of Kashipur PS also did in same tune. It was also told that if they didn't stop such illegal activities they would be no other alternative but to resort lathi charge or gas firing. In spite of this caution they did not pay any heed and more over they became more furious, come closer to wall with a view to scale for attacking us in a riotous mood. The distance was approx 30 mts which was reduced to 15 to 20 mts. As the distance was closer, there was every possibility of physical attack by those from all sides specially western side. Then as per order of Akhter Ali, DySP, Crime, Baruipur PD fired some round of Pump Action ,TS from gas gun ,plastic pallet, rubber cartridges stun shell, chased that mob to disperse from that place. Mean while that mob suddenly fired upon police and as a result Shri Maqsood Hasan, Addl SP (HQ) Baruipur PD and his security sustained bleeding bullet injuries in their left hand and left leg respectively. As the unruly supporters of ISF were firing among them, some of them might have sustained injuries of their own. Finally the mob dispersed from the place at about 2:30 AM and the Police personnel further took control of the area. It may be mentioned here that after ceasing of fire we conducted thorough search and one person namely Raju Molla was found near the venue (about 15 mtrs. from the Southern side wall) in injured condition who was shifted to Nalmuri Rural Hospital by SI Suman Ghosh of Kashipur P.S. and then there from he was shifted to Calcutta National Medical College and Hospital, who succumbed to injuries at 4:45 hrs. Another injured persons namely Hasan Ali Molla also succumbed to injuries at R.G. Kar Medical College and Hospital. Above information was received from Tala PS, Kolkata via mail. Some live unexploded crude bombs are also found lying near the venue and surrounding places. Accordingly BDDS of CID, WB was informed for taking necessary action for disposal of those bombs. He seized some articles & Vehicles The seizure was done in between 05:05 hrs and 08.25 hrs.
