3. **CID, WB Cyber Crime PS Case No-08/24 Dated:-24/09/2024 U/S-318 /319 /336/ 340/ 61(2)BNS.** On 24.09.2024 at 18.35 hrs one Pankaj Chowdhury, S/o-Late Nrisingha Chowdhury currently residing at GitaRam Hospital NH-34,Radharghat,Behrampore,Murshidabad 742187 lodged a written complaint to the effect that he was interested for taking a franchise of Kalyan Jewellers he searched Google for the same and found one link of Kalyan Jewellers while clicking the link he found one Google form link for applying for franchise. Then he submitted filled Google Form provided in the said website for the franchise on 23/07/2024. On 25/07/2024 he received a call from phone number 9056516261 to his mobile number 9434051976. The caller introduced himself as Mr. Rakes Kumar Dasora representative of Kalyan Jewelers and described the process of running franchise of Kalyan

Jewellers and also said that he would receive a mail from Kalyan Jewellers containing a form which has to be filled and submitted and he received a mail from email 'info@kalyanjewellersfranchise.net.in' in his mail pankajchowdhury.gitaram@gmail.com with a checklist of required documents like Aadhaar card, Pan Card and other documents and also mentioned to send the details to support@kalyanjewellersfranchise.net.in. Accordingly, he submitted the form along with documents and sent to support@kalyanjewellersfranchise.net.in on 31/07/2024. Thereafter, they called him and asked for making payment of Rs-5,90,000/- (Five lakh ninety thousand only) as franchise fees and as per their assurance he paid the amount to the bank account number 60494946274 IFSC-MAHB0000379 as provided by them via RTGs vide SBINR52024082143075219 from A/c- 00000041259018225 IFSC Code-SBIN0000034 on 21st August 2024 and again make payment of Rs-23,60,000/- (Twenty three lakh sixty thousand only) as agreement fees on 29th August 2024 vide RTGS -SBINR520024082944670290 Dated 29.08.2024. After the payment Mr. Rakes Kumar Dasora contacted him and said that they will visit the projected place physically on 20 th Sept. 2024 and for that another payment is to be made. When he disagreed for making further payment they agreed and informed him that they would visit the projected site on 19/09/2024 for making agreement. But after that he was unable to contact the said number 19th Sept. 2024 and after verification from Kalyan Jewellers came to learn that he is a victim of fraud. Arrested one Hariom Singh (30 yrs) DOA- 04/04/2025 s/o Lt. Devi Singh of Vill-Mustafabad, PO-Parkham, PS-Farha, Dist- Mathura, UP.
