



On 23.02.2015 in between 17.15 hrs to 19.05 Inspector Sarbari Bhattacharya of AHTU, CID, WB along with officers & force of AHTU section held raid to work out a credible information a brothel is running at a road side hotel cum brothel situated at Terepekhyia village, Khirishtala near Mahishadal Hospital more, Ps. Mahisadal, Dist. Purba Medinipur for commercial sexual exploitation trade engaging young girls who has been procured from different places of West Bengal. During raid eight accused persons were arrested and eight victim girls (four of them are minor) were rescued.
