**C) (iii) Important arrest and property found in the possession of arrested persons with reference to other Crimes :-**

Details of the Case	
1.	Asansol North PS Case No. 55/16 dated 10.03.2016 u/s 399/402 IPC & 25(1B)(a) /27 Arms Act was started on the complaint of ASI Biswajit Kapri of Asansol (N) P.S Dist Burdwan, that on 10.03.16 at 22.35 hrs to 22.45 hrs received a source information, complainant along with force held raid near Melaburi Mandir, Nuni Jhar, Kalyanpur area under Asansol (N) PS and found a gang of 8/9 dacoits armed with deadly weapons assembled at the said place. But getting the sense of Police the assembled persons tried to flee away but somehow 04 persons were apprehend namely (1) Md. Selim @ Behara (22 yrs) S/o Lt. Umar Rajjak @ Meharoom of Lalchowk, Kasai Mohalla, PS Asansol (N) Dist Burdwan (2) Md. Basim @ Wasim (23 yrs) S/o Md. Akbar of Do. (3) Md. Feku (28 yrs) S/o Md. Suleman of Nunka Chowraha, PS Khajkala, Dist Patna (Bihar) A/p Kasai Mohalla near Idgah, PS Asansol (N) Dist Burdwan and (4) Md. Kalam @ Kalma (22 yrs) S/o Md. Selim of Chandmari Kissmat Nagar, PS Asansol (N) Dist Burdwan. On searching found 04 (Four) improvised iron made pipe gun loaded with 04 (Four) rounds live cartridge (2) one iron made knife of length approx. 12", (3) nylon rope length approx. 30 ft. and (4) one iron made shabal of length approx. 2.6 " seized on being interrogated the apprehended accused persons failed to supply any documents or any satisfactory answer regarding possessing of the weapons. On further interrogation they confessed their guilt and stated that they along with Badri of Azad Basti and others have assembled there for committing dacoity at Kalyanpur Housing Estate under Asansol (N) PS. Accordingly the complainant seized the above noted arms & ammunition.





The office situated at 179E, Ground Floor, Khirki Village, Malviyanagar, New Delhi- 110017 vide RBI Reg No. B14.02484. The complainant deposited Cash Rs. 9,48,616/- at their branch office situated at Raghunathpur, Dist. Purulia. Over the incident the case was registered and the above noted person was arrested.
