He has also been providing various bank account details along with internet banking IDs and passwords of many other persons to his foreign agent through Telegram and other applications. In return, he has earned a large amount of money via Bitcoins, US Dollars, and cash. Moreover, he has promised the same agent that he will supply Indian 1000 SIM cards without documents to Dubai or Cambodia. Many screenshots of suspicious chats and images of various bank account details were found on his mobile phone. The information was diarized, brought to the notice of superiors and as directed, a raid was conducted at the house of Tanmoy Dutta on the night of 24.09.2024/25.09.2024 with assistance of Belgharia PS. In course of search,

some incriminating documents and two mobile phones of the said person were seized. Arrested one Tanmoy Dutta (39) s/o Mihir Dutta of 9/10, Amulya Charan Paul Street, Nowdapara P.S- Belghoria, North 24 Pgs, PIN- 700057.

On 13.08.2024 at 23:55 hrs. received a written suo-moto complaint from SI Soumalya Aich of STF, West Bengal to the effect that on 12/13.08.2024 in pursuance of source information, he along with officers and forces, apprehended one accused person namely Raju Sk (45yrs) S/O-Lt Ersad Sk of Vill- Natun Chandra P.O- Dofahat P.S-Suti, Dist- Murshidabad. As per his confessional statement he recovered and seized Total 111 Kgs approx. of Explosive Substance in different colours viz. (i) One white colour sack containing 50.160 Kgs of white colour powder seem to be explosive substances marked as exhibit "A" and 50 grams of white colour powder seem to be explosive substances taken from exhibit "A" in a plastic with navy blue cap marked as exhibit "A1"(taken as sample), (ii) One white colour sack containing 50.230 Kgs of white colour powder seem to be explosive substances marked as exhibit "B" and 50 grams of white colour powder seem to be explosive substances taken from exhibit "B" in a plastic container with navy blue cap marked as exhibit "B1"(taken as sample), (iii) One white colour sack containing 10.800 Kgs of orange colour stone-type material seems to be explosive substances marked as exhibit "C" and 50 grams of orange colour stone-type material seems to be explosive substances taken from exhibit "C" in a plastic container with blue cap marked as exhibit "C1"(as sample), and others documents from Jagmaya Transport, Aurangabad Branch at Mominpara, PS- Suti, Murshidabad. Later he arrested him under proper custody memo.

**iv) Amdanga PS Case No 585/24 dated 25.08.24 U/S 20 (b) (ii) (C)/25/27A/29 NDPS**

**Act 1985:** The instant case was started over the written Suo-moto complaint of SI Subhomoy Ghosh of Special Task Force, West Bengal to the effect that on 25.08.24 at 08.15 hrs, he received a secret information from source that a dealing of huge quantity of Ganja i.e. narcotic contraband article will be held today in between 15:00 hrs to 16:00 hrs at Royalmade Dhaba compound, beside NH 34, Kalyani Bound flank, under Amdanga Police Station, Dist.- North 24 Pargana. Then along with Amdanga PS team He recover and seized 204 Kgs (approx) seems to be Ganja as shown and brought out by the accused persons (i) Nripen Bairagi (M/36 Yrs) S/O- Haren Bairagi of Kashimpur Sukanta Pally , PS-Duttapukur, Dist- 24 PGS (N), Pin- 743248 and (ii) Chand Babu (M/26Yrs) S/O-Mohd Rais of House No-205, Vill Gurer Post Khas, PS: Mainather, Dist: Muradabad, UP-244001. They also seized the truck bearing registration number UP21CN8521 And Approx 1330 nos of paper cartoons containing Hair Oil. During further search of the 10 wheeler container truck bearing

registration number UP21CN8521, recovered rupees 125,000/-.Over this above noted case was started at Amdanga PS.
