



On 28.03.2024, acting on a secret source information, a team of SOG, CID, WB, held raid at an unauthorized call center styled as 'EVERSTONE TRUST CAPITAL SERVICES', situated at 1st Floor of 2909/E/40, Barrackpore Road, Ward No. 4 under Barasat PS, North 24 Pgs. where Manik Badsha Seikh, Abhisekh Samanta, Rohan Nag, Sandip Sarkar and others used to run a clandestine business of fake call center. They used to cheat common people throughout India by dishing out false promises of high monthly income in lieu of installation of mobile towers, purchasing of various health insurance and educational products, Health Card using the name of reputed companies. Leading to the statement of accused persons, raid was held at 'DIGI INDIA CAPITAL SERVICES', situated at the 1st floor of the commercial house of Debjit Ghosh s/o Amarendra Nath Ghosh of Uttar Nabapally, Talikhola, Barasat where some female and male persons were sitting in front of long desk talking suspiciously over phone. Nine accused persons were arrested and some incriminating articles like diaries, exercise book, documents, and mobile phones were seized.

Acting on a secret source information, a team of CID, WB held raid at an unauthorized call centre styled as ED Web Solution Pvt. Ltd. at Merlin Infinity Building, 10th Floor, Room No. 1009, Plot-51, Block-DN, Sector-V, Salt Lake, Kolkata- 700091 where accused persons used to call the people residing abroad by impersonating themselves as representatives of United State Subsidy Federal Fund and dupe the people of US in the name of subsidy scheme and somehow bound them to pay a good amount of money for obtaining the subsidy scheme which actually never served. They also cheated people in aboard by impersonating themselves as the representatives of different reputed companies in the name of creating delivery hub in their residence by alluring of huge monthly income. The racket was being run under the leadership of Deepak Jha, Ishan Jaiswal, Avishek Saha and Sourav Bhowmik. Eight persons were arrested and mobile phones, hard disks and documents were seized.
