

The fact of the case in brief is that on 06.07.15 in pursuance of an information made by Dharmapal Premchand Ltd having its corporate office at A-34 & 35 Sector-60, Noida- 291301 (U.P) India Inspector M. N Das along with other officers and force of E.B, W.B being accompanied by the personal of Dharmapal Premchand Ltd and assisted by officer and force of Golabari Ps had been to the Godown cum workshop situated at 17A, Pilkhana 2<sup>nd</sup> Bye Lane, Ps- Golabari, Howrah. During inspection they found owner of the above Godown cum workshop Birendra Kumar Sarma s/o Lalan Sarma of vill- Chanp, PO- Chanp, Ps- Akorigola, Dist- Rotash, Bihar along with 7 (seven) workers were engaged in storing manufacturing and selling duplicated and counterfeited products of Dharampal Premchand Ltd. Like BABA 120 Zarda pouch and container of different quality of 'BABA' which belongs to Dharampal Premchand Ltd. and their infringing the copy right of the above name company. On demanded they could not able to produce any papers for running such illegal business. Hence they were arrested for violating the Copy Right for the above noted name Dharampal Premchand Pvt. Ltd. A huge number of products of Dharampal Premchand Pvt. Ltd. like 'BABA 120' raw materials along with one old machine were seized from the possession of the accused persons. Value of the seized articles is approx 5,00000/- . On the basis the above noted case was started and SI Santosh Sarkar of E.B, W.B took up its investigation.

(5) **Interesting detections by CID, West Bengal :-**

**Ref : Baguiati Ps Case No. 576 dated- 03.07.15 U/s 363/365/366A/370 read with section 34 of Indian Penal Code and section 3/4/5/6/7/9 Of the Immoral Traffic Prevention Act 1956 and Section 17 of Protection of Children from Sexual Offences Act, 2012.**

On 03.07.15 in between 16.00 hrs to 22.00 hrs acting on a tip off Inspector Srabari Bhattacharjee OC AHTU, CID, W.B along with other officers and men of AHTU, CID, W.B held raid at a private residence cum brothel situated at Sree Maa Abasan, AB 8/27, Deshbandhunagar, Ground floor flat, Ps- Baguiati, Kolkata- 700059, on the allegation at of commercial sexual exploitationof girls. During raid the following two accused persons were arrested from the said residence/brothel, who were carrying on sexual exploitation of girls in exchange of money namely :- (1) Subhendu Das (51) S/o Lt. Gouranga Sundar Das of Sree Maa Abasan, AB 8/27, Desbandhunagar, ground floor flat, Ps- Baguiati, Kolkata-700059 and also of 85, Baithak Khana Road, Ps- Amherst Street, Kolkata- 700009 (2) Dipika Mondal (33) D/o Jagadish Pandey, W/o Khokon Mondal of Midha Market goli, near Ramkrishna Pharmacy, PS- Baguihati, Kokata-700059. During raid three minors and three major girls were rescued from the residence/brothel. On the basis of Suo-moto complaint the above noted case has been started and took up its investigation.
