Halalpur, Ps. Dhantala, Dist. Nadia.(5) Saheb Sarkar @ Sahensha (27 yrs) s/o- Subash Sarkar of Madanpur Gouranga para, PO. Madanpur, Ps. Chakdah, Dist- Nadia. (j) 5 Kg of Explosive substances (powder). It was unearthed that the accused persons were running illegal arms factory and were dealing in illegal fire arms and ammunition and explosives. Raid continued late in the 22.8.15 afternoon. SI Atish Chatterjee submitted complaint over the matter and Kalyani Ps Case No. 534/15 dt. 22.8.15 u/s- 25/27/35 Arms Act 9B (II) I.E Act, ¾ E.S Act was started against the above noted accused persons. The arrested accused persons will be forwarded before Ld. ACJM Kalyani court on 23.8.2015.
