**NOTIFICATION**

**Subject: Creation of West Bengal Cyber Crime Wing (WB-CCW) along with creation of 188 new posts of different categories and transfer of 305 posts of different categories from 4 (four) stand alone units under West Bengal Police.**

1. The complaints related to cyber crime are presently looked after by the existing 34 (thirty four) Cyber Crime Police Stations under different Commissionerate/Districts and by one Cyber Crime Police Station under Criminal Investigation Department, West Bengal. Apart from these, there are 4 (four) stand alone units under West Bengal Police which are also looking after cyber related matter under the West Bengal Police. In order to ensure administrative convenience and better management of the cyber crime related matters, the West Bengal Police Directorate has submitted a proposal vide Memo. No. 557/ORG//ORG-27/23, dated 17.08.2023 for creation of West Bengal Cyber Crime Wing (WB-CCW) under West Bengal Police.

2. After careful consideration of the matter, the Governor is pleased to accord approval to the following:-

- (a) Setting up of West Bengal Cyber Crime Wing (WB-CCW) under West Bengal Police and standalone units i.e. Cyber Patrol Cell, Cyber Crime Cell, Cyber Forensic and Digital Evidence Examiner's Laboratory (CFDEEL) under CID, W.B. & Emergency Response Support System (ERSS) will be shifted to that wing.
- (b) WB-CCW will have overall administrative control over Cyber Crime Police Station of Criminal Investigation Department, West Bengal only while remaining 34 Cyber Crime Police Stations under West Bengal Police will continue with same jurisdiction as before (under administrative control of concerned jurisdictional Commissioners/ Superintendents of Police of the Police Districts) but will be supervised by WB-CCW.
- (c) Creation of 188 (134 regular posts + 54 IT personnel by engagement) new posts of different categories as stated below:-
