ii) Atrport PS Case No.247/23 Dated-06.12.2023 U/S- 20(B)(II)(C)/25/28/29 of NDPS Act, 1985 –

iii) Cyber Crime Malda PS Case No- 42/2021 dt 21.09.21 u/s 406/464/468/419/420/120B IPC -

The above noted case was started on 21.09.2021 over the written complain of one Sajal Mandal S/O Nimai Chandra Mandal of Vill-Rameshwarpur, PO- J.Rathbari, PS-Englishbazar, Dist-Malda against unknown miscreants to the effect that on February 2021 he received some unknown calls impersonating themselves as staffs of Reliance Jio and offered for installation of mobile tower on the land of the complainant along with job offer of Security Guard and Monthly rent of Rs 12,500/-. The complainant was tricked to pay certain amount of money in different installments for various reasons at various occasions in 14 different Bank accounts showing him fake payment receipts to be credited in his Bank Account. Unfortunately, after paying a total sum of Rs 6,63,400/-(Six Lakhs Sixty Three Thousand and four hundred) he understood that he had been cheated as no money was debited in his Bank Account.
