4. Important detections made by West Bengal Police:- Barasat Cyber Crime PS Case No-51/25, Dated- 17.11.2025, U/S- 316(2)/318(4)/319(2)/61(2)/ 111 of BNS. On 17.11.2025 one namely Shantanu Mondal S/o-Prasanta Mondal of 33/3 Ashoknagar, North 24 Parganas, West Bengal, 743222 came at PS and lodged a complaint regarding money fraud of an amount of Rs. 13,50,000/- to the effect that in on 27.08.2025 the complainant joined an invitation through Whatsapp for joining a group called Capital Operations Group 333 in August 2025 administered by a person introduced himself as Parveen Patel (Mobile No. 91

8670364594) and he joined this group. He used to give stock recommendations as well for buying and selling stocks at a given price. Later Mr. Patel advised that by trading as a Qualified Institutional Buyer (QIB) during pre-market hours can give huge profits. Mr. Patel introduced with one Mr. Harper (Mobile No. 91 9578870996) was senior Operations Manager and opened a demat account in TenCore by downloading the app from Google Play store. Mr. Harper used to guide the group members for depositing amounts which are going through different third party bank accounts. He totally deposited Rs. 13,50,000/- to a different bank account and got profit from QIB trading stocks around Rs. 50 Lakhs accumulated in Ten Core account. Then as insisted by Mr. Harper applied for MIDWEST IPO through TenCore and was allotted the shares of around Rs. 88 lakhs, but he was unable to pay to get all allotted shares. He tried to withdraw his money, but he was unable to do so. Then he got to know that he has been cheated by the fraudster. He also lodged a complaint on National Cyber Crime Reporting Portal vide Ack. No- 23211250060230. Over this matter the case has been started. Arrested one Madhusudan Biswas S/O- Lt. Mrinal kanti PS: Chinsurah, District: Chandannagar Police Commissionerate.
