Barijaksha Mukherjee of Vill- Anara, PS- Para, District- Purulia to the effect that few years ago on 07/08/2017 one unknown person (Mob No- 7044762783) called the complainant and disclosed himself as an executive of Bharati Airtel Mobile Tower Company and told the him that his land has been selected for telecom tower installation and gave him an alluring offer of providing Rs. 92,50,000/- as lease money for land, Rs. 32,500/- as monthly land rent and one care-taker job for one of his family members. Later another person called him (Mob No- 8583832712, 7431099856) and introduced himself as Regional Officer of that tower company and took some of his personal documents and land deed documents through WhatsApp. Then the said regional officer asked for some money as registration fees and for that on 03/10/2017 the complainant sent Rs.60,000/- to a bank A/C No- 32358873674, IFSC- SBIN0000157 of SBI from his Bank A/C No- 139001501676 of ICICI Bank. After the payment the unknown persons demanded more amount as Income Tax, Pollution certificate, Panchayat NOC, structure fees and for other excuses and being convinced the complaint from his two bank accounts vide i) A/C No - 139001501676 of ICICI bank and ii) A/C No- 11377317860 of SBI, in between 12/02/2018 to 04/01/2020, sent more amount of Rs. 15,66,000/- to some bank accounts vide i) A/C No- 915010060584562 of Axis Bank ii) A/C No- 3368793852 of SBI iii) A/C No- 881024426619 of Digi Bank iv) A/C No- 50170019288869 of Bandhan Bank v) A/C No- 50100227835051 of HDFC vi) A/C No- 35083887846 of SBI vii) A/C No- 881009614462 of SBI viii) A/C No- 504510488594 of Allahabad Bank ix) A/C No- 35578615688 of SBI x) A/C No- 37289541877 of SBI xi) A/C No- 33933449746 of SBI xi) A/C No- 5017009288809 of Bandhan Bank and xiii) One more account of SBI whose account number is not being remembered currently by the complainant. In this way the complainant sent a total amount of Rs.16,26,000/- to the aforesaid accounts. The complainant also informed that for receiving the agreement money he was convinced to make a bank account (A/C No- 40830052296 of SBI, Anara Branch) in his name and send it to an address given by aforesaid person, which was later closed by him. Later when the complainant asked them the reason for the delay in installing the tower, they gave him the excuse of Covid-19. Later on, November, 2022 when the said representative again asked for more amount for TRAI approval, the complainant realized that he has been cheated. Over this the above noted case has been registered and as per endorsement of I/C Cyber Crime PS, Purulia SI Anjan Kumar Biswas took up its investigation, on 24.02.2023 arrested the main accused Rohan Talukdar S/o-Sourav Talukdar, of 42/23 Murari Pukoor Road, Sani Mandir, PS-Manicktala, Dist.-Kolkata,WB.
