Acting on a secret source information, a team of CID, West Bengal held a raid at an unauthorized call-centre styled as ED Web Solution Pvt. Ltd. at Merlin Infinity Building, 10<sup>th</sup> Floor, Room No. 1009, Plot - 51, Block -DN, Sector-V, Salt Lake, Kolkata-700091. The accused persons used to call the people residing abroad by impersonating themselves as representative of United State Subsidy Federal Fund and duped the people of US in the name of subsidy scheme and insisted them to pay a good amount of money for obtaining the subsidy scheme which actually never existed. They also cheated victims staying aboard by impersonating themselves as the representatives of different reputed companies in the name of creating delivery hub in their residence by alluring of huge monthly income. The racket was being run under the Leadership of Deepak Jha, Ishan Jaiswasl, Avishek Saha and Sourav Bhowmik. Five Persons were arrested namely 1) Shidhartha Basawatia(31) S/o-Gokul Basawatia of 17 Nimtala Ghat Street, PO+PS-Jorabagan, Kolkata-700006 2) Gopi raut(24) S/O-Dina Raut of 8 No Shiv Nandi Lane ,PO-Barabazar PS-Posta, Kolkata-700007. 3) Raju Mallick(42) S/O-Paban Mallick of Sujjan Bagan Chinsurah, PS- Chinsutrah Dist.- Hooghly 5) Anirban Das (35) S/o- Amiya Kumar Das of Jotir More , PO+PS – Chandannagar Dist Hooghly and incriminating documents and articles were seized.
