(Sl nos 9, 10 found from the possession of accused Sukumar Mondal)
11. One country made 7.65 mm pistol, measuring about 7.5", fitted with butt, barrel, hammer, firing pin etc. loaded with four rds of 7.65 mm live cartridges in its removable magazine
12. One country made pipegun measuring about 11", fitted with butt, barrel, trigger, hammer, firing pine etc. loaded with one round of 8 mm live cartridge
13. Four (04) rounds of live 8 mm cartridges
(Sl nos 11-13 found from the possession of accused Tapas Das)
14. One (01) DBBL Gun, having inscription Girid & Sons on its barrel, it's length is about 47". It is fitted with butt, barrel, trigger, hammer, firing pin etc.
15. 20 (twenty) rds of live 12 bore cartridges
(Sl nos 14, 15 left by absconding accused Deepak Haldar of Balipukur)
16. One country made pipegun measuring about 11", fitted with butt, barrel, trigger, hammer, firing pin etc. loaded with one round of 8 mm live cartridge
17. Four (04) rounds of live 8 mm cartridges
(Sl nos 16, 17 left by absconding accused Manik of Balipukur) all labeled, packed and sealed
18. Thirty seven (37) pieces of live socket bombs
(Twenty pieces of bombs seized fom Anandapally area and 17 pieces from Balipukur area) Two of the criminials, Viz. Deepak Haldar and Manik, both of Balipukur area managed to escape. Over the fact a written complaint was submitted at Kalyani Ps against accused persons and two absconders and the above noted case was started. SI Subimal Biswas of Nadia DD was took up its investigation of the case.
