#### **4. Important detections made by West Bengal Police:-**

**i)** Malda Cyber Crime PS Case No.42/21, Dated 21/09/2021, U/S-406/467/468/419/420/120B IPC. On 21.09.2021 one Sajal Mondal S/O- Nimai Chandra Mondal of Vill-Rameshwarpur, PO-J.Rathbari, PS- Englishbazar , Dist Malda came to PS and submitted a written complaint against unknown miscreants to the effect that on February 2021 he received calls from unknown person who impersonated themselves as staffs of Reliance Jio and offered for installation of a mobile tower on the land of the complaint along with job offer of security Guard and Monthly rent of Rs-12,500/- for the space where the Mobile tower was to be installed. The complaint was tricked to pay a certain amount of money in different instalments for various reason at various occasion in 14 different bank accounts showing him fake payment receipts to be credited in his Bank Account. After paying a total sum of Rs- 6,63,400/- on different occasions he understood that he had been cheated. Arrested 1. Utpal Ghosal,S/O- Dulal Chandra Ghosal of P-9 Jubilee Park, Kathodanga Road, PS – Sarsuna, Kolkata-700061.

**ii)** Tollygunj PS Case No.213/22 dated- 08/11/2022 u/s- 120B/420/406 IPC & adding Section 467/468/471 IPC. On Since February 2022 the FIR named accused Kaustav Sahana had approached the complainant with an assurance that he would settled the dispute arising on the landed property of the complainant. He also assured that he would manage to sell the disputed property. To resolve the dispute of land of the complainant, accused koustav Sahana, claimed that he would file a case in the High Court, Calcutta on behalf of the complainant. He further assured the complainant that he would appoint renowned lawyersfrom the Hon'ble Supreme Court of India and High Court Calcutta to represent th complainant. Using this promise, he took additional money from the complainant. He also taken her signature in a vakalatnama for filling a case in the High Court, Calcutta. Later the accused kaustav Sahana and his associates created fake order sheets of the Hon'ble High Court,Calcutta in respect of W.P No.31312(W) of 2022 and also produced it to the complainant and complaint Mrs.Gouri Roy is an octogenarian lady and she was unhappy with the investigation. She filed a writ Petition before the Hon'ble High Court, Calcutta vide No. WPO/295/2024.

On 08.04.2024 the Hon'ble High Court, Calcutta heard the matter and directed further investigation of this case CID, West Bengal. Accordingly the case was assumed by CID West

Bengal Vide Crime West Bengal Org No.495/CS dated 18/04/2024. Arrested one Koustav Sahana (29) S/O- Lt. Malay Sahana of 62/1 Laxmi Narayan Tala Road, PS- AJC Bose B Garden, District- Howrah.
