**Bagdogra PS Case No. 231/2023 Dated:01.06.2023 U/S-188/285/286 IPC r/w Sec. 24 of west Bengal Fire Service Act.** was started over the written complaint of SI Sibdhan Karmakar of Bagdogra PS against one arrested accused person namely Subhdip Das(29) S/O-Subankar Das of Khudiram Pally PS Bagdogra Dist- Darjeeling to the effect that on 01.06.2023 at 14-40 Hrs. During PC Van duty received a secure information that one person have been storing and selling Fire-Crackers from his Godown Cum shop name and Style as Shyam Bhandar Station more without having any license or other valid documentsviolating the provision of law which may endanger human life and likely to cause injury. Accordingly he informed the matter to OC BagdograPS and as per direction he along with other officers and force left for the spot to verify the veracity of the information and on arrival at station More PS Bagdogra on being identified by the source they cordoned the said shop in presence of witnesses and held raid in that shop and apprehended the above noted accused person and on searched the complainant recovered (1) 60 (Sixty) boxes of RHINO POWER Chocolates bombs each box containing 10 pices Chocolates bombs total 600 pices manufactured by SS. Enterprise (2) 04 boxes Supreme Colorkti each box containing 10 Pcs. Total 40 Pices manufactured by Enjoy Fyre Works (4) 05 boxes of Save water flammable Magic box bombs each box containing 03 pcs of total 15 Pcs. Of manufacture by Ganesh Fire works Factory Sivakashi (5) 02 boxes of Vanitha Colour cone each box containing 10 pcs total 20 pcs (6) 01 box of Elite Royal Shots 30 manufactured by Bheema Shiva Kash(7) 40 Packets of king cobra Electric crackers each containg 50 Pcs manufactured Muthu Fireworks Industries, Siva Kashi(8) 02 boxes of colour Fog jaiSri Krishna Smoke Fountain each box containing 2 pcs total 04 pcs from the possession of the said person from his shop . On demand the apprehended person failed to produce any valid documents/licenses. The said accused person was storing and selling fire crackers which are combustibile in nature and endanger to human life and property.

### PART IV-

#### 1) Miscellaneous Notices -

**(A)** As Per the Notification of High Court Calcutta Vide Memo No. 8265-RG Dated. 23.08.2023 In Pursuance of the Hon'ble Supreme Court of India, contained in the Judgement dated 31.07.2023 passed in Criminal Appeal No.2207 of 2023 arisig out of

SLP(CrI)No.3433 of 2023 [Md. Asfaq Alam -vs- The State of Jharkhand & Anr]and with the approval of the Hon'ble the Chief Justice, the following guidelines are framed by the High Court at Calcutta to be followed by the Sessions courts and all other and Criminal courts within the territory of West Bengal and Andaman & Nicobar Islands, dealing with various offences:

“The endeavour of the Hon'ble Supreme Court in the above mentioned judgement is to ensure that Police Officers do not arrest the accused unnecessarily and Magistrate do not authorize detention casually and mechanically. In order to ensure the above, the Hon'ble Supreme Court has been pleased to give the following directions.

1. All the State Governments to instruct its Police Officers not to automatically arrest when a case under Section 498A IPC is registered but to satisfy themselves about the necessity for arrest under the parameters laid down above following from Section 41 Cr.P.C.
2. All the Police Officers be provided with a check list containing specified sub-clauses under Section 41(1)(b)(ii).
3. The Police Officer shall forward the check list dully filled and furnished the reasons and materials which necessitated the arrest, while forwarding/Producing the accused before the Magistrate for further detention.
- 4.The Magistrate while authorizing detention of the accused shall peruse the report furnished by the police officer in terms aforesaid and only after recording its satisfaction the Magistrate will authorize detention.
- 5.The decision not to arrest an accused be forwarded to the Magistrate within two weeks from the date of the institution of the case with a copy to the Magistrate which may be extended by the Superintendent pf Police of the district for the reasons to be recorded in writing.
6. Notice of appearance in term of section 41-A Cr.P.C be served on the accused within two weeks from the date of institution of the case, which may be extended by the Superintendent of Police of the district for the reasons to be recorded in writing.
7. Falure to Comply with directions aforesaid shall apart from rendering the police officers concerned liable for departmental action, they shall also be liable to be punished for contempt of court to be instituted before the High Court having territorial jurisdiction.
- 8.Authorizing detention without recording reasons as aforesaid by the Judicial Magistrate concerned shall be liable for departmental action by the appropriate High Court.

The Hon'ble Supreme Court hasten to add that the direction aforesaid shall not only apply to the case under section 498-A IPC or Section 4 of the Dowry Prohibition Act, the case in hand but alsosuchcases where offence is punishable with imprisonment for a terms which may be less than seven years or which may extened to seven years, whether with or without fine.

#### 4. Important detections made by West Bengal Police:-

##### **i) Domjur P.S. Case no 547/23 Date-03/08/22 U/S 20 (b) (ii)(C)/25/29 of NDPS Act.**

On 03/08/2023 at about 11:05 hrs. receipt of a credible source information that a gang of professional criminals will be dealing with huge quantity Ganja transported illegally in commercial quantity falls under NDPS Act, 1985 in clandestine way and they will procure, sell those to different users for wrongful gain and the criminals also carrying contraband articles through private vehicle will be passing through NH-16 Ankurhati under P.S-Domjur jurisdiction, and they would transport such quantity of the said items from Orissa in noontime on 03/08/2023.

In view of the above fact, the case started & arrested two accused persons namely 1) Bapon SK (29) s/o AlauddinSk of Village Harakrishnapur, PS Sagarpara, DistMurshidabad 2) JhantuMolla (30) s/o IndadulMolla of MollahrChak, Natial, Murshidabad – 742308 along with seized articles/properties i.e. 1) Reddish colour flower top of Cannabis plant with grain believe to be Ganja wrapped in brownish colour industrial tape total packs 98 and weight 164.530 Kg.

Approximate value of seized articles are Rs 18,00,000 in retail market. Proper seizure list was prepared, with signatures of witnesses and accused persons and also gave the copy of seizure list to the accused persons and they acknowledged the receipt. The seizure list, inventory list, labels were certified by Gazetted Officer.

##### **ii) Barasat PD Cyber Crime PS Case No : 02/23 Dated 22/02/2023 US 420/406/120B IPC &660 Information Technology Act, 2000 (Relevant Provisions).**

The instant case has been started on the basis of Written Complaint of Subhendu Sarkar, S/o-Lila Sarkar of Nisarga, Udairajpur, Madhyamgram, North 24 Parganas, 700129 to the effect that from 2019 to 2022 one Siddhratha Sarkar residing at 1 Bijoynagar, Krishna Sadhukhan Road, Near Shib Mandir, Naihati, PIN- 743165 and his three associates trickled the said complainant by creating fake G-mail Ids, WhatsApp accounts and cheated him with Rs. 4,65,14,550/- (Rupees Four crore sixty five lakh fourteen thousand five hundred fifty).

**iii) CID Cyber Crime PS case no 09/22 dated 18.08.2022 U/S u/s 419/420/468/471/120B IPC and 20/20A of the Indian Telegraph Act 1885.**

**Gist** - The fact of the case in brief is that on 17.08.2022 at about 18.05 hrs, Sub-Inspector Shri Atanu Chakraborty of Barasat DD , CID West Bengal hold raid a international Fake Call Centre namely as Krishnansh Business Solutions Pvt. Ltd. DN Block, DN-62, Millenium City, Sector-V, Salt Lake, Kolkata-700091 which used to call mainly customers of Microsoft and other renowned companies in USA, UK, and Australia, Germany and UAE introducing themselves as the representative of different companies like Microsoft, Amazon etc on the pretext of providing technical support to the customers. They were running this illegal business by engaging unemployed youth.

**iv) Ghola P.S Case No. 328/22 Dt. 31.05.22 U/S 418/419/420/467/468/471/120B/34 IPC.**

Inspector, Nilanjan Ray, DDI,Barrackpore DD, CIDWB submitted a written complainant before the Officer-in-Charge,Ghola P.S.Barrackpore Police Commissionerate. Dist. 24 Pgs. (North) on 31.05.2022 at 21.15hrs. against i) Bablu Das s/o Lt. Durlav Das of Taltala, Mahendranagar, PS Ghola, Dist.24 Pgs. (N) (M-9477410083/8240479944) ii) Sk. Samsul Alam (Sk. Kalam) s/o Sk. Faizel Vill & Po Chalk Kashipore PS Nodakhali Dist. 24 Pgs (S) (M- 9051125698) and others to the effect that the accused persons established a foundation trust styled as “Mission Mamata Again CM”, All India Foundation Trust in the year 2019 and later on changed the name of said foundation trust style as “Mission Mamata, All India Foundation Trust but it was not registered. No PAN or Bank account was generated against both the said trusts. Complainant informed that those persons used to collect money dishonestly through the mission in the name of Hon’ble Chief Minister of West Bengal and used to misappropriate the collected money. They also used the photographs of Hon’ble Chief Minister of West Bengal without her prior permission. They committed the offence of criminal intimidation and pressure to the common people to grab the public money through this mission for their personal interest. They dishonestly concealed the original fact and miss led the common people with intention to fulfill their wrongful gain. They used to convince common people to donate money delectably in the said trust without prior permission of the Hon’ble Chief Minister of West Bengal. Complainant also noted that in anticipation of order of superior’s officers of CID West Bengal.

**v) Howrah PS Case No. 256/23 dtd 21.07.2023 u/s -436/427/120B IPC & 11J/11L/12 of West Bengal Fire Service Act 1950.**

on 21/07/2023 at 13:50 hrs Shri Pradip Patra, O/C of the Fire, Howrah Fire Station, West Bengal Fire and Emergency Services lodged a written complainant at Howrah PS to the effect that on 21.07.23 at about 00.55 hrs. a devastating fire has taken place at 1 No. Kartick Chandra Dutta Road, Pora-hat under PS Howrah where 18 No. of water tender, specialized appliances, equipment’s, man power were deployed to combat the fire accordingly. The complainant also added that authority/ owner of that Hat set up business in violation of section 11C, 12 of West Bengal Fire Service Act which is punishable u/s 11J, 11L and 12 of said Act. Over this complaint Howrah PS Case No. 256/23 dtd 21.07.2023 u/s -436/427/120B IPC & 11J/11L/12 of West Bengal Fire Service Act 1950 has been recorded. As per endorsement SI SarfazAlam of Howrah PS took up its investigation. Subsequently as per kind order of Crime West Bengal vide Org No. 688/CS Dated – 21.07.2023, CID West Bengal has controlled the investigation of this case and entrusted Howrah DD for investigation the case. Accordingly, SI Asit Dey of Howrah DD, CID West Bengal took up its investigation of this case on 24/07/2023. Thereafter aggrieved shop owner / Babasayee Samiti submitted complain on that incident date and several petitions of the ill-fated aggrieved traders addressed to OC Howrah PS were duly forwarded to us for assessing mischief and quantification of loss incurred thereof wherein the statements and documents were taken under consideration of this case on same cause of action / fact.

**vi) Keshiary PS Cae No.184/17 dtd.13.12.2017 u/s-302/201/34 IPC.**

Today on 26/08/2023 at about 12:10 hrs araid was held jointly by paschim Medinipur DD,CID,WB and Keshiary PS and Digha PS at New Digha area under PS – Digha, Dist- urba Medinipur and arrested two accused person namely 1) Phatik Ranjan Pahari @ Fatik(58 Yrs) S/O Lt.Bhimapada Pahari of Vill- Begampur, PO+PS-Keshiary,Dist – Paschim Medinipur and 2) Kartik Palai @ Kartik Palui(53)S/O-Lt. jata Palai of Vill- Meghadambur, PO-Nachipur, PS-Keshiary ,Dist-paschim Medinipur . They weer forwarded before Ld. Chief Judicial magistrate , Paschim Medinipur along with 14 days Police remand of both the accused persons and the Ld. Court allowed 14(fourteen) days police remand of both the accused persons .

**vii) Anti Corruption Branch Police Station Case No.06/23 dated 22.06.2023 U/S 13(1) (A) of the Prevention of Corruption Act, 1988 as amended vide Prevention of Corruption (Amendment) Act 2018 and 409/120B IPC.**

Shri Souven Ray S/O Sachindra Nath Ray, Resident of Ward No – 03 Malancha Pally, PO-Mokdumpur PS- Englishbazar Dist- Malda, Working as Excutive Assistant , Bairagachi –II Gram Panchyat, Under Gazole Dist. Malda. 3. Shri Apurba Bahari, S/O-Late Gourango Bahari of Vill+Po-Khutadaha, PS- Bamangola, Dist Malda, Pin- 732138,working as Nirman Sahayak, Bairagachi-II Gram Panchyat, under Gazole Develophment Block, Malda have been arrested on 17.08.2023. The arrested accused person have been forwarded before the Court of LD.Addl. Dist&Session Judge, Bench-II Bichar Bhawan Kolkata on 18.08.2023.
