



The fact of the case, in brief, is that Received a written complaint on 20.02.2022 at 23:20 hrs of the complainant Sri Ravi Bhalotia S/o Mahendar Bhalotia of Rambagan near Sanjeevani Nursing Home, Rambagan Doctors Colony, PS-Raniganj, Dist- Paschim Bardhaman, to the effect that on 20.02.2022 at about 20:15 hrs when complainant along with his mother, younger brother, some

neighbors and others household staff were doing daily household scores, suddenly 08/09 unknown persons forcefully entered through the main gate of our house after overpowering the guard and when the complainant opened the main door suddenly all the 08/09 persons aged about 18-30 yrs armed with Pistol, Revolver overpowered the complainant and entered their ground floor and started assaulting him with fist and blows and threatened all family members with dire consequences showing firearms. They also forced the complainant's mother to take them on the other floors of the house in search of cash and other valuables. The complainant alleged that took away our 06 mobile phones out of which 04 nos mobile details are vide One Plus having IMEI no- 869796043277592, One Samsung mobile having IMEI no- 354156120653326, One Redmi mobile having IMEI no- 86676905518519606, one Redmi mobile having IMEI no- 869514051798882 and one smartwatch of Apple and few small bags of Senco Gold marked, cash Rs 15,000/- including some valuable documents & ATM card, etc. Soon after the complainant heard shouting of Police and on hearing the shouting of Police addressing the miscreants to surrender at that time said miscreants started to flee away through the complainant's back door and they started indiscriminate firing towards the Police party and left complainant's house. The Police team managed to apprehend 03 miscreants namely Manoj Kumar, Chandan Kumar Sahani, and Akash as identified by them. During this chase and firing by the miscreants 03 persons, 01 public Bibek Chowdhury and 01 Police officer received bullet injury. One of the miscreants received a bullet injury also. Chatterjee Sarani, PS-Serampore, Hooghly, Pin 712203 came to PS and lodged a written complaint to the effect that he has been trading in Bitcoin with an organization named CAE. He had agreed to join a plan offered by CAE and had invested money for gain. As per the norms he had to pay 25% commission to the analyst each day after trading. Accordingly, he paid. After payment of commission and profit percentage he was asked to pay 10% as tax to release his money which also he paid. Then again, he was asked to pay 10000 USDT as security deposit. Lastly, he realised it to be a fraud. The fraud amount is in the tune of Rs. 4297687. Accordingly, the case was started, accused two -

1. Manish Kumar (25 yrs) s/o Ram Kumar address of House No. 1J/40 NIT-1, Block-J, Dist-Faridabad, Haryana, PS- Kotwali, Pin- 121001.

v) Chandannagar Cyber PS Case No. 02/23 dtd. 10/01/2023 u/s 419/420/406/467/468/471/34 IPC & Section 66D IT Act.

The fact of the case in brief is that on 10.01.2023 at 14:15 hrs received a written complaint from one namely Somvu Roy, S/O Lt. Ranjit Roy Barasat, Dashabhujia Tala, Garerdhar, PS- Chandannagar, Dist- Hooghly to the effect that on 20.10.2022, one Puja Roy, an agent of Airtel company had called him and convinced the complainant for installation of tower in his own premises and as a result

complainant paid Rs. 2,26,800/- in various steps from his friend's account. The communication was done through the mobile numbers 7479303767, 7044897784, 7478461091, 7479160862, and 7439783245. The accused persons defrauded the money. Hence the case has been started.

vi) Bidhannagar Cyber Crime PS Case No. 32/2023 dated 25.03.2023 u/s 379/409/420/500/120B IPC. The fact of the case is that a letter was received from Saequa Monazza (Chief administrative officer) of West Bengal State Council of Technical and Skill Development Department. Roughly 30000 students are participating in each semester's exams. It had come to notice since June-July 2022 when the 3rd and 5th odd semesters were being held that students of Engineering and Technology in the Polytechnic system are indulging in mass cheating through the Telegram App across centers in different locations of the state. This year the odd semester exams started on 21st March and were scheduled to continue till 31 March 2023. Based on the written complaint a specific case has been registered vide Bidhannagar Cyber Crime PS Case No. 32/23, dated- 25/03/23 u/s- 379/409/420/500/120B IPC. Several complaints were also lodged in various police stations of West Bengal. A case was started at Gaighata PS vide FIR No. 271/23 dtd 21.03.2023 u/s 188 IPC. Another complaint had also been lodged at Bishnupur PS vide GDE 1095/12 dtd 22/11/2022. Another case was started in Technocity Police Station vide case no 128/22 dated 07/07/2022, accused name -
