

On 11.09.2021 he along with his other staff namely Abhishek Chakraborty, Sonali Gupta, Kingshuk Mukherjee were present in the branch and performing work smoothly and one security guard Anil Kumar Pandey also present in the Branch. At around 13.58 hrs one person came to the Branch and offered a chain for Gold Loan. He produced an Aadhar Card and disclosed his mobile number. At that time another one customer namely Babu Paswan was present in the Branch and his staff Abhishek Chakraborty was verifying the ID of other 03 persons came to the Branch. Then one of the men took out firearms and pushed their Branch Security Guard and assaulted him with a blunt portion of the firearms and he fell down on the floor. One of the miscreants rushed to Maruti Courier services adjacent to his office and forcibly brought the daughter of the Maruti Courier service owner. All officer staff with the complainant kept in a cabin at his gunpoint and threatened them. Then they assaulted the complainant with the blunt portion of the firearms and pushed the barrel of the firearms inside his mouth and collected the strongroom keys. Then tied the hands of all the staff with rope brought by them and closed their mouths. They tried to open a strong room door with the keys but they failed. Then they forcibly asked the complainant to open the strong room door and almirah. After that complainant was compelled to open and they took out two white color bags from their backpack and looted the ornaments vide GL A/C No. F3449, F3438, F3761, F3808, F3813, F3864, F3883, F3891, F3909, F3926 & 698 from the almirah. They also took away cash Rs. 9,21,964/- and two cheque books and dummy swarnavarsham jewelry samples. They operated the DVR Box within twenty minutes.
