#### 4. Important detections made by West Bengal Police:

i) Amdanga PS Case No : 872/25 Dated 12/12/2025 US 143 BNS & 24(1) The Immigration and Foreigners Act, 2025. The instant case was started over the sou-moto written complaint of the complainant namely Asish Bagri, SI of Police, SOG section, CID West Bengal against (1)Jakir Hossain Mondal (33) S/O Kausher Mondal of Vill-Sabiapur, P.O-Nockful, PS-Bongaon, District-North 24 Parganas to the effect that on 12/12/2025 at about 11:35 hrs, the complainant received an information from his credible source that one Jakir Hossain Mondal of Bagula of Hanskhali PS area has illegally procured an young Bangladeshi girl from Bangladesh through IB border at Bangula side to traffic the said girl to Hyderabad through his other associates on 12/12/2025 night by train via Howrah railway station. After receiving information he along with other police personnel accompanied by Amdanga PS Police assistance hold raid near Sonadanga abaitanik Prathamik Vidyalaya, PS Amdanga, North 24 Parganas hold raid on 12.12.2025 at about 16.35 hrs, and then they apprehended one motorcycle bearing Reg No WB12X-2086, accordingly their raid team intercepted the said motorcycle and placed the same besides NH-12 in front of Sonadanga Abaitanik PrathamikVidyalaya, Sonadanga, Kamdebpur, Amdanga, North 24 Parganas. After that one rider and one pillion rider unmounted from the said motor cycle and during primary interrogation they disclosed their identity as mentioned above and the female counter part admitted that she belongs to Bangladeshi national. Then they brought them to Amdanga PS for further course of interrogation. On interrogation he stated his name and addresses as noted above and also stated that he procured the lady from Bangladeshi tout with false promise for providing her a lucrative job at Hyderabad. He was schedule to hand over the lady to his another associate to traffic her to Hyderabad for the purpose of prostitution. On being asked the said accused also disclosed that they are operating a racket of illegal human trafficking through India-Bangladesh Border. In which they are in well contact with their agents in the Bangladesh side. Young and needy girls of BD sides are being trapped and are being infiltrated to this India side illegally and with the help of the other group members of this racket these girls are being kept in their secret hide outs and fake Indian identities such as Voter, Adhar cards etc are being prepared. And then these girls are being sold to the agents of different parts of the country for the purpose of prostitutions. All the group members are actively working in this racket to gain huge quantities of money and they have already trafficked a good numbers of girls to different states of India. He also interviewed the recovered victim lady and she stated that she is from Bangladesh. One person who she knows as "Bhaiya" contacted her and offered her to provide good job at Hyderabad. The said Bhaiya made necessary arrangement to cross the I.B border illegally through touts. Today afternoon she started from Bagula area with one person namely Jakir Bhai by his motorcycle. Later after reaching near Sonadanga Abaitanik Prathamik Vidyalaya, Sonadanga, Kamdebpur, Amdanga, North 24 Parganas, police recovered her. After thorough interrogation myself search the alleged person and seized articles as enclosed herewith under proper seizure list from 17.35 hrs to 18.55 hrs and 18.55 to 19.45 hrs with proper video graphy as per BNSS and subsequently, arrested the alleged person on 12.12.2025 at 19.55 hrs after maintaining all the legal guidelines of NHRC & Hon'ble Apex Court. From the above facts

and circumstances, it was quite clear that the young Bangladeshi lady has been transported and trafficked from another country with a clear intention of exploiting her. Arrested one person namely Jakir Hossain Mondal S/O – Kausher of PS: Bongaon, District: Bongaon Police District, State: West Bengal.

**ii)** Cyber Crime PS, CID, WB PS Case No : 02/25 Dated 18/08/2025 US 318(4)/319(2)/338/336(3)/61(2) BNS. The fact of the case in brief is that on 18.08.2025 one Somnath Roy (52 years) S/O- Lt. Sri Chandidas Roy of 182/2/A, Ichapur Anandamath, P.O-Ichapur Nawabganj, PS-Ichapur, Dist.-24 Paraganas (North) lodged a complainant at CID Cyber Crime Police Station. He is filing this complaint regarding a serious case of online investment fraud involving a website and mobile application impersonating “360 One,” a reputed financial advisory service. The fraudsters lured him into investing substantial amounts and now refusing to allow withdrawal of his funds unless he pays an additional amount under false pretenses.
