Kundu of village Kalikapur, PO Sharappur, PS Dumuria, district Khulna, Bangladesh, (8) Dipankar Mondal (22) s/o Goutam Mondal of Rajarhat Bishnupur Bosina Mondal Para, PS Rajarhat, PO Bishnupur, Kol- 135 & (9) Sanjay Sarkar (32) s/o Lt. Netai Ch. Sarkar of Adarshapally Shimultala, PS Baguiati, Kol- 159 to the effect that on 18.12.16 at 13:20 hrs the complainant received information from reliable source that the accused No. (8) is manufacturing forged ADHAAR CARD in the house of Sanjay Sarkar at Adarshapally, under Baguiati PS in association with Subrata Bapari, s/o Sukharanjan Bapari, of Gouranganagar, PS New Town for some illegal Bangladeshi immigrants and one Bangladeshi advocate namely Subrata Kr. Kundu who came here on the strength of one Bangladeshi Passport and VISA is also there for helping those illegal Bangladeshi immigrants. The complainant along with force held raid at the P.O and succeeded to detain the aforesaid accused Persons from the P.O on interrogation the accused persons Vide Sl. No. 1 to 5, introduced themselves as Bangladeshi. But other than accused Subrata Kr. Kundu none was able to produce valid Passport and VISA in support of their entering into India from Bangladesh. All the illegal Bangladeshi including Subrata Kr. Kundu stated that said Sanjay Sarkar and Subrata Bapari contacted said Dipankar Mondal who is a ADHAAR card operative of a concern called Sankalp Karvy. The vender, Soma Chakraborty W/O Prabir Kundu, of Kalibari, PS Rajarhat, and Dipankar was offered huge financial benefit for the manufacture of ADHAAR CARDS for said illegal Bangladeshi to get Passports. On interrogation Dipankar Mondal, Sanjay Sarkar and Subrata Bapari admitted the aforesaid fact to be true. Aforesaid Dipankar Mondal also admitted that he used to manufacture the huge number of forged ADHAAR CARD by using his Laptop and the details of which are stored in his laptop. On searching of the accused persons the following articles recovered and seized (i) One laptop (ii) One web camera (iii) One old & used live scan fingerprints/identification hats device (iv) One old & used Cogent Scanner (v) One currency of Bangladesh Bank of five hundred (vi) Two currency of Bangladesh Bank of one hundred (vii) One currency of Bangladesh Bank of fifty (viii) Two currency of Bangladesh Bank of Twenty (ix) One Passport of people Republic of Bangladesh in the name of Subrata Kr. Kundu (x) One Certificate of Khulna District Bar Association in the name of Subrata Kr. Kundu (xi) One photocopy of Adhaar enrolment in the name of Shraboni Hazra (xii) One photocopy of Adhaar enrolment in the name of Anushri Prodhan (xiii) One photocopy of Adhaar enrolment in the name of Anamika Goldar (xiv) One electric bill of West Zone Power Distribution Co. Ltd. In the name of Sk. Abbush Uddin Ahmed, of 9/11, Rokon Uddin Sarok of Khulna.
