#### e) Dum Dum GRPS Case No. 61/2015 dated 10.09.2015 u/s 489/489C/120B IPC.

On 16.2.2018 The Ld. ADJ, FT 2<sup>nd</sup> Court, Sealdah passed an order against the accused, namely Mona Mondal (45) d/o Fatik Mondal (w/o Chittaranjan Mondal) of Gharani para, PS Krishnagar, District Nadia A/P Gopinath Mandir, Vrindavan, Mathura, Uttar Prodesh for six (6) year imprisonment due to transaction and dealing of fake FICN's of total Rs. 1,00,000/- which was investigated by CID, West Bengal.
