Police Order No. 01 of 2021

Dated the 10th February, 2021

Subject: Supervision and monitoring of CCTV Cameras in police stations.

The Hon'ble High Court at Calcutta vide an order passed on 8th January 2021 in WPA 5327 of 2020 with CAN 1 of 2020 in the matter of Court in it's own motion, has issued certain directions in respect of supervision and monitoring of proper and effective functioning of CCTV cameras which have already been installed and are going to be installed in the police stations and proper maintenance thereof.

2. In compliance with the directions of the Hon'ble High Court, the following instructions are hereby issued:
 - i. All ICs/OCs of police stations including GRPSs will personally inspect functioning of CCTV cameras on a regular basis and submit report to the CP/SP/SRP concerned as soon as any CCTV camera or recording system is found to be not functioning properly.
 - ii. On receipt of such information CP/SP/SRP concerned will send an available technical team immediately for inspection and carrying out necessary repairs or restoration work as early as possible and positively within 24 hours.
 - iii. CP/SP/SRP will take steps for Annual Maintenance Contract (AMC) for CCTV Camera and recording system.
 - iv. Each Police Station will maintain a log book wherein the defects as well as steps taken for repairs or restoration should be noted.
 - v. DCP (Headquarters)/Addl. SP (Headquarters) will act as Nodal Officer in this respect in the Police Commissionerates/Police Districts. In GRP districts, SRP will remain Nodal Officer.

- vi. CID, West Bengal, being the Nodal Agency, will periodically monitor status of CCTV cameras and recording systems. CID should also be contacted by field units in case of any necessity in this regard.
3. This order will come into force with immediate effect.

In partial modification of Police Order No. 2 dated 18.05.2017 following amendment to the Order is issued. In the Section "Diet of Animal" the sale of feed shall be as follows:—

Sl. No.	Feed Item	Quantity per day
1.	Crushed Oat	3.0 kg
2.	Wheat Bran	2.0 kg
3.	Bengal Gram Whole	0.5 kg
4.	Horse Gram (Kulti)	0.4 kg
5.	Linseed	200 gms
6.	Hay	5.0 kg
7.	Green Grass	3.0 kg
8.	Straw for Chaff	1.5 kg
9.	Straw for bedding	5.0 kg
10.	Black Rock Salt	80 gms
11.	Common White Salt	80 gms
12.	Carrot	0.8 kg
13.	Molasses/Cane Jaggery (Gur)	0.3 kg
14.	Soyabean Oil	25 ml
15.	Water	25-70 ltrs. (Four times minimum)

All other Sections shall remain unchanged. Annexure-I, Daily feed of an Adult Horse shall be modified for proportionate distribution of the revised quantity of feed.
