On 20.04.2020 around 16:35 hrs SI Krishnendu Mandal, OC Licence Section HPC lodged a complaint to the effect that on 11.05.2017 one new arms licence was issued to Sri Deepak Narayan Amin s/o Narayan Bhai Amin of 46/2/E, Moulana Abul Kalam Azad Road, PS- Golabari, Dist- Howrah. Subsequently he purchased one .32 bore pistol vide no 170102607 by GSF from M/s D.N. Biswas & Co Kolkata-01 and the same was brought for inspection and endorsed in his licence after enquiry. However, subsequently the weapon was found in a new design and colour. Accordingly an enquiry was sent to GSF Cossipore for its veracity and it is learnt that the new arms was Ashani Pistol manufactured at Punjab, which was sold illegally forging the designs in the name of Indian Ordnance Factory. The chains of culprits are identified. Further investigation is proceeding.
