It appears from the email dated 18.04.2026 that petitioner alleged that without having any requisite degree, certificates and mark sheets of WBBS, Suchinvaran Pura (WBBS) Reg. No-483545, Sanyan Pura (WBBS) Reg. No. 51944 and Archo Kumar Nandi (WBBS) Reg. No. 541548 were able to enter their names in the Indian Medical Register through West Bengal Medical Council. They took huge fees from the patients and still now making prescriptions on their own without representing themselves as holders of WBBS and any additional degree. Till now the aforesaid three doctors have not registered their names on National Medical Register Portal and in NMC (National Medical Commission). The petitioner said that Suchinvaran Pura illegally has earned at least Rs. 100 Crores, Sanyan Pura around Rs. 200 Crores and Archo Kumar Nandi earned around 70 Crores. Petitioner requested to provide information on the following points: 1.
